Subject: Capital Budget Monitoring 2018/2019 - General Fund Capital

Programme

1. Purpose of Report

1.1. The purpose of the report is to:-

 update members of the Financial Resources Scrutiny Forum of progress on the Council's General Fund Capital Programme for the period covering 1 April 2018 to 22 June 2018.

2. Recommendation(s)

- 2.1. The Forum is asked to approve the following recommendation:
 - that the physical and financial progress of the 2018/2019 General Fund Capital Programme be noted.

3. Background

- 3.1. The Capital reports attached provide detail on the position as at 22 June 2018 from both a financial and physical perspective.
- 3.2. Appendices A and B show the financial position of the General Fund Capital Programme, with the physical progress detailed in Appendices C to E as they are split into Build, Non Build and Roads.

4. Update to 2017/18 Programme

- 4.1. The original budget for the year of £73.194 million was approved by the Council on 28 February 2018.
- 4.2. Sections 4.3. to 4.10. details movement in the programme since 28 February 2018.
- 4.3. Since the approval of the original budget, a further two budget amendments for Rural Development Centre, Lanark £0.800 million and Springhall Regeneration Project £0.375 million were agreed at Executive Committee on 16 May 2018 and 28 March 2018 respectively.
- 4.4. **2017/18 Carry Forward:** As reported in the Final Outturn Report for 2017/18 a carry forward total of £20.593 million will ensure sufficient budget is available to conclude ongoing projects within the General Fund Capital Programme.

- 4.5. <u>Transfers to Revenue</u>: The original budget for 2018/19 included an allocation of £1.000 million for Private Housing Scheme of Assistance. However, as this expenditure cannot be classed as Capital, it has been transferred to Housing and Technical Resources' Revenue budget.
- 4.6. <u>Primary Schools' Modernisation Programme</u>: The 2018/19 requirement reported to the Council was £10.744 million. Since then, the timing of expenditure has been reviewed to reflect the most up to date profile of works reallocating £1 million of the 2018/19 budget requirement to 2019/20. There has been no change in the timescales for delivery of the completed schools.
- 4.7. Glasgow City Region City Deal: A recent review of project expenditure has been undertaken which has included taking cognisance of the anticipated project approval dates by the City Deal Cabinet. To reflect actual profiling of spend, slippage of £11.861 million has been identified in the 2018/19 Programme. These monies will be carried forward into future years, to conclude these projects.
- 4.8. Social Work Residential Facilities: Discussions on developing proposals for new care facilities are ongoing. The allocation of £5 million within 2018/19 will be moved into financial year 2019/20 at this point.
- 4.9. Street Lighting: The Column Renewal Programme commenced in June 2015, with the aim of replacing 7,253 of the existing lighting columns over a 5 year programme. It is now envisaged that these columns will be replaced ahead of schedule, with the full programme of column replacements completed by September 2018.

 Based on this, financial savings of £3.123 million will also be realised from the original programme. This has been achieved through savings in material costs as a result of mini competitions being used to procure luminaire and also through improved productivity. This saving will be realised through a reduction to the 2018/19 and 2019/20 Programmes (£1.5 million and £1.623 million respectively).
- 4.10. Education Information Computer Technology (ICT): Based on a review of the spend profile for the ICT refresh programme, slippage of £1.226 million has been highlighted which will be required in 2019/20.
- 4.11. Extension / Improvement of Cemeteries: The timing of spend in relation to the extension and improvement of cemeteries is dependent on the availability of land. Land investigation work and acquisition negotiations will progress in 2018/19 with land purchase costs of £1.5 million now likely to occur into 2019/20.
- 4.12. **Property Investment**: Funding was provided over the 3 year capital programme for spend in relation to both the Prioritised Urgent Investment in Property project and Headquarters Fabric Upgrade project. The profile of spend has been reviewed and slippage of £0.550 million will be carried forward into 2019/20 to complete the programme of works.
- 4.13. Springhall Regeneration Project: Planning in relation to the redevelopment of Springhall Community Hall is ongoing with the main contract works expected to commence on site in 2019, following consultation with the local community to inform the design and procurement process through 2018. The replacement of the existing library roof will commence on completion of the Community Hall project, allowing the relocation of the library service. This is now reflected in the 2018/19 spend profile. The funding, including Regeneration Capital

Grant funding which needs to be committed by the end of March 2019 (£0.250m), will be carried forward into 2019/20.

- 4.14. **2018/19 General Services Base Budget Position:** Taking into account the movements noted in 4.3. 4.13. above, the General Services Programme for 2018/19 is £70.625 million. This is the base budget for the financial year.
- 4.15. This is summarised in the table below.

5.1. None

6. Financial Implications

6.1. <u>2018/19 Budget</u>

Section 4.14.- 4.15. above shows the base budget for the financial year as £70.625million. The detail of this across Resources is shown in Appendix A to this report.

- 6.2. In the first three months of financial year 2018/19, amendments to the Capital Programme have been proposed by Resources totalling a net increase of £2.095 million. These were submitted to the Executive Committee's on 27 June 2018 (increase of £2.691 million) and the 15 August 2018 (decrease of £0.596million). These are detailed in note 1 and note 2 to Appendix B.
- 6.3. The revised programme for the General Fund is £72.720 million as shown in Appendix A. This revised programme consists of the base budget plus carry forward projects, previously approved adjustments and adjustments to the programme as noted in Appendix B.

6.4. Period 4 Position

Budget for the period is £9.037 million and spend to the 22 June 2018 is £9.195 million (12.64%). This represents expenditure of £0.158 million ahead of profile.

- 6.5. Actual funding received to 22 June 2018 is £46.397 million (63.80%).
- 6.6. Appendices C to E advise on the related physical progress of the General Fund Capital Programme for 2018/2019 and these are split across three elements: Build; Non-Build and Roads.

7. Other Implications

- 7.1. The main risk associated with the Council's Capital Programme is an overspend. The risk has been assessed as low given the detailed project management plans prepared and monitored for each project. The risk of overspend is managed through four weekly Investment Management Meetings.
- 7.2. There are no implications for sustainability in terms of the information contained in this report.

8. Equality Impact Assessment and Consultation Arrangements

- 8.1. This report does not introduce a new policy, function or strategy or recommend a change to existing policy, function or strategy and therefore no impact assessment is required.
- 8.2. There was also no requirement to undertake any consultation in terms of the information contained in this report.

Approval is sought to increase the 2018/19 Capital programme by £0.240m to reflect additional funding received from Heritage Lottery Fund (£0.164m) and Smarter Choices Smarter Places (£0.075m). Early Years – 1,140 Hours Expansion

Confirmation was received from the Scottish Government on 1 May 2018 of a total funding allocation for this Council of £19.240m for the expansion of Early Learning and Childcare to 1,140 hours. £1.740m has already been received in 2017/18 with further allocations for 2018/19 (£5.900m), 2019/20 (£6.900m) and 2020/21 (£4.700m). Approval is sought to increase the 2018/19 Capital Programme by £1.530m to allow early design and implementation work to progress.

Grass & Synthetic Pitch Replacement

Approval is sought to slip £0.300m into the 2019/20 Capital programme to fund (£0.300m) further pitch upgrades next financial year outwith playing season.

Springhall Community Hall

Planning in relation to the redevelopment of the Springhall Community Hall facility is ongoing. Initial draft designs have now been developed and in order to enable the refurbished facility to meet the aspirations of Council services, elected members and the local community who have been consulted as part of this process, an estimated budget of £0.900m is required. Approval is sought to transfer further match funding of £0.450m from the Prioritised Urgent Investment Fund. This will result in a total project budget for the Community Hall of £0.900m.

Following the results of the initial monitoring regime at the former landfill site at Glen Esk, East Kilbride, there is a requirement for further tests to be carried out. This will enable the contract to be awarded in February 2019 and allow Scottish Government funding for this project to be secured. As such, approval is sought to allow slippage of £0.750m into the 2019/20 Capital Programme to align with the commencement of works.
