1 Declaration of Interests

No interests were declared.

2 Minutes of Previous Meeting

The minutes of the meeting of the Board held on 13 March 2017 were submitted for approval as a correct record.

The Board decided:

3 Appointment of Convener and Depute Convener

A report dated 10 May 2017 by the Clerk was submitted on:-

- the procedure to be followed by the Board in appointing its Convener and Depute Convener following the Local Government elections held on 4 May 2017
- the levels of remuneration for each position in terms of the Local Governance (Scotland) Act 2004 (Remuneration) Regulations 2007 and subsequent amendments

Councillor Shields, seconded by Councillor Castles, moved that Councillor McVey (North Lanarkshire Council) be appointed as Convener of the Board. Councillor McManus, seconded by Councillor Valentine, moved that Councillor Baird (North Lanarkshire Council) be appointed as Convener of the Board.

On a vote being taken by show of hands, 8 members voted for Councillor McVey and 6 members voted for Councillor Baird. Councillor McVey was declared Convener of the Board.

On a vote being taken by show of hands, 8 members voted for Councillor Hamilton and 7 members voted for Councillor Dorman. Councillor Hamilton was declared Depute Convener of the Board.

6 2016/2017 Annual Report and Accounts for Lanarkshire Valuation Joint Board

Appendix 1 to the report detailed the 2016/2017 outturn position for the Board which showed a drawdown from reserves of £0.080 million. After implementing statutory accounting practice, the net balance on the Board's General Fund Balance was zero.
