# 1 Purpose of Report

- 1.1 The purpose of the report is to:-
  - ◆ advise the Estates Committee of the transactions processed through Estates delegated authority during the period 1 January to 31 March 2005.

#### 3 Background

3.1 The Estates Section of Estates and Support has delegated powers to deal with Lease Transactions of a value up to £50,000 per annum and a maximum period of 10 years and capital transactions up to a value of £150,000.

# 4 Volume of Transactions 4<sup>th</sup> Quarter 2004/05

4.1 Appendix 1 shows the transactions for the period 1 January to 31 March 2005 and an annual summary.

Total number of transactions this guarter 45

Total value of lease transactions this quarter £134,905
Total value of capital transactions this quarter £552,476

- 4.2 The majority of lease transactions relate to the granting of new leases (16 out of 30).
- 4.3 The most significant new letting being 622m<sup>2</sup> unit at Peel Park, East Kilbride on a 5 year lease at £30,000 per annum.
- 4.4 Eight out of the nine acquisitions were for Housing Services. Four of these acquisitions were for houses to supplement the Council Housing Stock and the remainder were in connection with redevelopment proposals.
- 4.5 Of the 5 disposals, 2 were industrial sites and 2 were residential development opportunities at Glespin and Law.
