1. Purpose of Report

1.1. The purpose of the report is to:-

 provide information on the progress of the capital programme for Community Services for the period 1 April to 28 June 2013

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that the Community Services' capital programme of £6.854million, and expenditure to date of £1.140million, be noted.

3. Background

- 3.1. This is the first capital monitoring report presented to the Community Services Committee for the financial year 2013/2014.
- 3.2. The Community and Enterprise Resources' budget is managed in totality by the Resource. The report details the financial position for Community Services in Appendix A. For information, the report also details the financial position for Community and Enterprise Resources in total in Appendix A.

4. Employee Implications

4.1. None.

5. Financial Implications

5.1. The total capital programme for Community Services for 2013/2014 is £6.854million. This includes budget adjustments approved at the Executive Committee on 26 June and 28 August 2013. Anticipated spend to date was £1.238million with £1.140million of expenditure being incurred (16.63% of full budget). This represents a position of £0.098million behind profile. This time last year £0.728million was spent (7.15%).

6. Other Implications

- 6.1. The main risk associated with the Council's Capital Programme is that there is an overspend. The risk has been assessed as low given the detailed project management plans prepared and monitored for each project. The risk of an overspend is managed through four weekly Investment Management Meetings.
- 6.2. There are no implications for sustainability in terms of the information contained in this report.

7. Equality Impact Assessment and Consultation Arrangements

- 7.1. This report does not introduce a new policy, function or strategy or recommend a change to an existing policy, function or strategy and therefore no impact assessment is required.
- 7.2. There is also no requirement to undertake any consultation in terms of the information contained in the report.
