Subject: Review of Operating Procedures and Management

Rules for Cemeteries

1. Purpose of Report

1.1. The purpose of the report is to:-

♦ inform Committee of the outcome of the consultation exercise on behalf of the Operating Procedures and Management Rules for Cemeteries.

 - that an amendment to clause 14.1 of the Management Rules for Cemeteries be approved.
 - (3) that the Operating Procedures and Management Rules for Cemeteries, as amended, be approved.

3. Background

- 3.1. The Community Services Committee considered the provision of Operating Procedures and Management Rules for Cemeteries on 30 October 2012. Contained within the report was the acknowledgement that the general public required to be consulted in order to gather their views on the proposals.

 - Council's Website
 - Libraries
 - Council Headquarter
 - South Lanarkshire Crematorium

Proposed Operating Procedures and Management Rules for Cemeteries

Results of Public Consultation

1. The first enquiry related to the termination of burial rights. Clarification, in particular, was sought on clauses 9.1 and 9.3 i.e.

Clause 9.1

• "Where all burial rights in respect of all of the lairs within a cemetery have been sold and the lair holder has not exercised the right of burial for a period of more than 40 years from the date of the original purchase, then the Council may terminate these rights of burial".

Reply:

The enquirer was advised that the termination of burial rights could only be used by the Council where the lair had never been used. That said, the Council, in practice, has chosen not to enact termination rights preferring alternatively to develop new burial grounds.

Clause 9.3

 "If as a result of the termination of these burial rights any headstone or other monument will require to be removed, the Council will remove the headstone or other monument and store the headstone or monument."

Reply:

Yes, the Council would remove the headstone or other monument and safely place it in storage should such a termination of burial right occur.

2. The second enquiry related to the register of burials.

Clause 10.1

• "The Council will keep a register detailing the name, age, date of death and last residence of all persons buried in the cemetery and will also detail the lair in which the persons have been buried".

Reply:

The Council has a statutory obligation to retain a register of all those interred in South Lanarkshire Cemeteries.

- 3. The second set of comments related to a range of issues i.e.
 - "Concern was raised into the opening and Closing of cemetery gates (Rutherglen Cemetery)".

Reply: The Council has a set framework which it operates to in regard to the opening and closing of cemetery gates.

• "People are not allowed to remove plants planted by the Council. What about plants planted by relatives?"

Reply:

Yes it is correct in that plants planted by the Council should not be removed and, equally, plants planted by relatives should not be removed either.

"Dogs should be on leads. That's fine but the modern leads are those that can
extent to great lengths to the extent that the dog can be some distance from its
owner".

Reply:

It was explained to the enquirer that any purpose built dog lead would be considered acceptable.

 "Planting is permitted at the head of the lair but shall not infringe over the part to be opened for burial. Does this mean that if the lair has not to be reopened the people can plant over the entire length?"

Reply:

No, planting should occur at the head of the lair in the headstone soil border. It is recognised however that a degree of discretion is required when dealing with the sensitive process of bereavement and, to this effect, an amendment to clause 14.1 of the proposed Management of Cemeteries rules is proposed i.e.

14. Amendment

- 14.1. The Council shall be at liberty to alter these Rules and Regulations or any part of them, at any time as they may see fit and may enforce (or decline to enforce) such Rules as they think fit for the proper or better management of the Council.
- There is no mention of flags, helium balloons, windmills, scarecrows, football shirts, tee shirts, scarves, or other items of a sectarian nature, rosary beads, trees, bushes being disallowed".

Reply:

The enquirer was advised that the description of specific items of memorialisation which was acceptable or not acceptable would have been too extensive to prescribe.
