5 Civic Government (Scotland) Act 1982 (As Amended) - Application for a Private Hire Car Driver's Licence

6 Civic Government (Scotland) Act 1982 (As Amended) - Application for a Skin Piercing and Tattooing Licence

A report dated 13 September 2017 by the Executive Director (Finance and Corporate Resources) was submitted on an application for a skin piercing and tattooing licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. An objection had been received from Police Scotland and Sergeant Tomlinson was heard. An observation had been received from Planning and Economic Development.

Councillor Miller, seconded by Councillor McGeever, moved that the application be granted. Councillor Thomson, seconded by Councillor Carmichael, moved as an amendment that the application be granted for a period of 1 year. On a vote being taken by a show of hands, 9 members voted for the motion and 10 members voted for the amendment which was declared carried.
