1. Purpose of Report

1.1. The purpose of the report is to:-

 provide information on the progress of the capital programme for Enterprise Resources for the period 1 April 2009 to 30 October 2009.

 - (1) that the Enterprise Resources capital programme of £30.826million, and expenditure to date of £13.121million be noted.

5. Financial Implications

5.1. The total capital programme for Enterprise Resources for 2009/2010 is £30.826million. Anticipated spend to date was £13.777million with £13.121million of expenditure being incurred (42.56% of full budget). This represents a position of £0.656m behind profile. This time last year £12.544million was spent (44.75%).
