# Subject: Byelaws Prohibiting the Consumption of Alcohol in Designated Public Places - Consultation on Revocation of Lanimer Day Waiver

# 1. Purpose of Report

- 1.1. The purpose of the report is to:-
  - provide information on the outcome of the public consultation exercise on the revocation of the relaxation of the byelaws which allow for the consumption of alcohol in public places in the town of Lanark on Lanimer Day

#### 2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
  - (1) that the outcome of the consultation on the revocation of the relaxation in the byelaws be noted; and
  - (2) that no further action be taken to revoke the relaxation of the byelaws for Lanimer Day.

# 3. Background

- 3.1. Following the decision of the Corporate Resources Committee on 1 October 2008, the Council carried out a consultation between 17 November and 1 December 2008 to gauge the views of the residents of Lanark and other interested parties about the possible change to the byelaws. A variety of consultation methods were used including:-
  - newspaper advert
  - direct mailing
  - opinion meters/online survey (the opinion meters were available between 17 and 24 November 2008)

# 4. Consultation Response

- 4.1 Of all respondents:-
  - 77% were against removal of the byelaw relaxation
  - 20% were in favour of removal
  - ♦ 3% were undecided
- 4.2 Only 1 response from a resident of Lanark was received to the newspaper advert in time, though a second response was received late. Both were against any change to the existing byelaws. The respondents viewed that policing would resolve the issue.

4.3 A number of interested parties were consulted by mail and in total 11 responses were received as follows:-

The Police indicated they were no longer actively seeking a change to the byelaws in relation to the Lanimer Day exemption.

4.4 The Council also received responses to a consultation process that had been privately organised. Some of the respondents did not provide full details as to identity and the questions posed within the privately organised consultation did not reflect those used by the Council. Without knowing the full background to how the consultation was organised, it may be necessary to approach the responses with care. However, taking account of these issues, the responses showed a large majority in favour of not changing the byelaws as follows:-

- 4.5 Opinion meters were placed within:-
  - Tesco and Somerfield Supermarkets
  - Lanark Swimming Pool
  - Council Offices in South Vennel
- 4.6. The survey looked at the perceptions of trouble at the Lanimer Day event and sought views on, whether a change in the byelaws would remedy that issue and the effect of any change of the byelaws on enjoyment of the event. The opinion meters registered a total of 313 valid responses and the online version of the survey received 85 submissions. This made a total of 398 responses. 54% of respondents felt that the Council should not amend the byelaws. This rose to 64% against a change from residents of Lanark. 38% of respondents were in favour of changing the byelaws. This dropped to 30% in relation to residents of Lanark. There was a majority view that there was an issue with anti-social behaviour caused by drunkenness on Lanimer Day. 52% of respondents consider that there was either a major problem (25%) or a problem (27%). However, 47% of respondents considered that there is no problem with anti-social behaviour caused by drunkenness on Lanimer Day. 41% of these were unsure and 6% did not know. In relation to enjoyment of the event, 47% of respondents would enjoy the Lanimer Day celebrations less if people were prevented from drinking alcohol in public places, 36% would enjoy the Lanimer Day celebrations more and 17% of respondents had no opinion or felt that there would be no impact on enjoyment.

### 5. Conclusion

- 5.1 Given that the majority of those who responded to the consultation are in favour of retaining the byelaw relaxation for the Lanimer Day event it is recommended that no further action is taken.
- 5.2 Work is still ongoing in respect of the proposed extension of the byelaws to cover other areas within South Lanarkshire and the introduction of a byelaw which prohibits the possession of an open container of alcohol in a public place. A progress report will be submitted to a future meeting of the Committee.
