# 3 Recommendations Referred by Executive Committee (Special) - Housing Revenue Budget 2006/2007; Revenue Budget and Level of Local Taxation 2006/2007 and Capital Investment Programme for General Fund Services 2008/2009

A report dated 9 February 2006 by the Chief Executive was tabled on the recommendations which had been referred to the Council by the Executive Committee (Special) held on 9 February 2006. The recommendations were as follows:-

#### **Housing Revenue Account Budget 2006/2007**

- ♦ that the Revenue Estimate proposals for the Housing Revenue Account for 2006/2007, as detailed in the report, and the weekly rent increase of £1.72 (3.5%) for Council houses, be approved
- ♦ that the 3.5% rise also be applied to the rent of lock-ups, garage sites and travelling people's sites

- that the budget allocations to each Resource for 2006/2007, as detailed in the report, be approved
