## **Payback Sports Facilities Fund**

## **Background**

This is a £3m fund. The aim of the fund is to promote the rehabilitation of offenders and help reduce reoffending by maintaining and improving sports amenities available to communities throughout Scotland. This work will utilise the labour of offenders sentenced to unpaid work in the community to upgrade / maintain those facilities. The funding will be provided by the Scottish Government to community justice authorities (CJAs) and though them to local authorities. CJAs and local authorities can cooperate with sportscotland or other delivery agents to ensure that the funding is used effectively and sustainably in accordance with community needs and aspirations. This work may also be suitable for promotion to local sport clubs through both Governing Bodies and Local Sports Associations. CJAs and local authorities should also consider opportunities to work with third sector partners to involve them in work on particular projects. The fund, as well as making an important contribution to the rehabilitation of offenders, will also contribute to addressing a previously identified need within Scotland for a facilities and infrastructure programme for sport. Increased participation in sport, which is enabled by having additional serviceable sports facilities in place, will help communities to sustain and improve their health one of the aims of the Healthier Scotland national objective.

The funding will be allocated to CJAs, up to £375,000 to each. This funding is intended to supplement existing work programmes in a way which provides work suitable for those on community payback orders and which also gives opportunities for worthwhile work of public benefit. The funding is intended to provide improved capacity in the number of available unpaid work placements. This will assist local authorities in starting offenders on unpaid work more quickly and will provide work which can help enhance the skills of offenders. Because the labour of community service / unpaid work offenders is available to local authorities without some of the costs otherwise associated with a labour force, spending will primarily be able to focus on investment that directly contributes towards improving the facilities involved. Work on community sporting facilities could include a diverse range of projects such as: improving football pitches, reconstructing bowling greens, upgrading changing room facilities, resurfacing tennis courts, and other work that improves community sporting assets and infrastructure.

The following objectives have to be met by each project supported by this fund:

- There should be demonstrable and quantifiable community benefit to the scheme (e.g. enhanced usage of the facility).
- The work should where possible enhance the employability of offenders, e.g. through links made to specific training qualifications.
- The facilities should be accessible to local communities and used primarily for a sporting purpose.
- There should be evidence of community support for the project (e.g. through responses to consultation exercises on unpaid work).
- The work to be undertaken by offenders should be considered by criminal
  justice social workers as suitable for those on a community payback order and
  should contribute towards achieving the requirements for speed and
  immediacy under the new CPO legislation and guidance.

## Project Process

Information on each project should be submitted to the Scottish Government. The Scottish Government will confirm from examination of the information that each project fulfils the objectives of the fund, as they are outlined above. If the expenditure does fulfil the objectives of the fund then a letter to that effect will then be issued to the relevant CJA Chief Officer. Payment of the funding will then be made, subject to the conditions outlined in that letter, and on receipt of invoices confirming when the expenditure was incurred and providing a breakdown of the costs. Invoices must be submitted to the Scottish Government no later than **1 March 2012**.

All submissions of information must be with the Scottish Government by **16 December 2011**. Projects submitted should not total more than £375,000 per CJA area. There is no requirement to rank or order projects but any expenditure in excess of £375,000 will <u>not</u> be funded. There is not an automatic entitlement to the full £375,000 and only projects that clearly demonstrate how they achieve the objectives of this fund will be supported. CJAs do not have to wait until they have projects totalling £375,000 before submitting details to the Scottish Government: details can be submitted for individual projects or for groups of projects up until the deadline of 16 December 2011. Projects will be considered at the point when details are received. Each submission must be self contained, in that details of any individual project should not span more than one template.

Agreement between local authorities and CJAs as to the projects that form part of their submission should have been secured prior to details being submitted. CJA Boards, led by Conveners, should play a key role in determining the projects that are selected within their local areas, taking into account the views of their communities as they do so. Due regard should be made of the appropriateness of the work offenders are being asked to undertake, to make sure cognisance is taken of the skill levels of those doing the work and also the suitability of the work for those on a community sentence. Scottish Ministers will have final say over whether expenditure on projects meets the high-level objectives of the fund.

Since the money is to be advanced for a specific purpose, only costs directly attributable to that purpose should be included. All submissions received will be considered, in part and in full, as to whether they meet the objectives of the fund so all elements of expenditure will be judged as to whether they contribute to that objective.

Most of the expenditure paid out will be classified as capital expenditure. However, projects where there is an element of staffing or other revenue costs which can be shown to be **integral to the project proceeding** may also be considered.<sup>1</sup>

All funding from this source will have to be separately accounted for within CJAs annual accounts and in the Section 27 quarterly grant monitoring returns to the

Scottish Government as a separate line (under the "invoices" section, in a way which clearly identifies instances where there are non-capital costs).

Although approval may be granted in 2011/12 to proceed with a project, it is recognised that, given the nature of capital projects, that some may not be completed within the 2011/12 financial year. It is important as part of your submission to make clear in which financial year(s) the expenditure will fall. The Scottish Government may at points throughout the year ask for updates on this expenditure profile. In the event that any expenditure continues beyond 1 April 2012 and into the 2012/3 financial year, there will be a facility available within the Scottish Government to make further payments for that 2012/13 expenditure. However, that process will be contingent on accurate forecasting and monitoring taking place inyear during 2011/12 so that appropriate planning arrangements can be made to extend this funding into the following year.

Any CJA area that by the deadline date of 16 December 2011 has not submitted any projects to the Scottish Government or has submitted details of projects for an amount less than the full £375,000 will not have a further opportunity in the 2011/12 financial year to submit *unsolicited* projects to be considered for this funding. Scottish Ministers will consider on a case-by-case basis whether any CJAs where projects have not met the objectives of the fund will have a further opportunity to revise aspects of their projects and re-submit them within this financial year. This judgement will again be made on the extent to which projects as submitted fulfil the objectives of the fund and whether with further work they would be suitable.

If any CJA area has not submitted details amounting to its full allocation by 16 December 2011 then it will have an opportunity to submit projects in 2012/13 for any remaining amount up to the £375, 000 limit.
