5 Civic Government (Scotland) Act 1982 (As Amended) – Application for the Renewal of Taxi Driver's Licence No 018

A report dated 6 June 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the renewal of taxi driver's licence No 018 in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. A representation had been received from Police Scotland and Sergeant Rankin was heard.

Councillor McClymont, seconded by Councillor Gray, moved that the application be granted. Councillor Scott, seconded by Councillor Carmichael, moved as an amendment that the application be refused. On a vote being taken by a show of hands, 6 members voted for the amendment and 14 for the motion which was declared carried.

6 Civic Government (Scotland) Act 1982 (As Amended) – Application for Grant of a Private Hire Car Driver's Licence

A report dated 6 June 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. A representation had been received from Police Scotland and Sergeant Rankin was heard.

Councillor Razzaq, seconded by Councillor Donnelly, moved that the application be granted. Councillor Thomson, seconded by Councillor Carmichael, moved as an amendment that the application be granted for a period of 1 year. On a vote being taken by a show of hands, 10 members voted for the amendment and 9 for the motion. The amendment was declared carried.

The Committee decided: that the application by P McCann, 11 Viewfield Avenue, Blantyre for a private hire car driver's licence in the Cambuslang and Rutherglen zone be granted for a period of 1 year.

The Committee decided: that the application by M McLoughlin, 87 Scalloway Road, Cambuslang for the renewal of taxi driver's licence No 018 in the Cambuslang and Rutherglen zone be granted.

Civic Government (Scotland) Act 1982 (As Amended) - Licensing of Taxis and Private Hire Cars

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - request approval to instruct a survey:-
 - to assess whether or not there is an 'overprovision' of private hire cars in any of the zones of South Lanarkshire
 - to assess whether or not there is any significant unmet demand in respect of taxis in each of the zones of South Lanarkshire
 - to consider whether the current provision of wheelchair accessible vehicles in each zone of South Lanarkshire is sufficient

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that a survey be instructed to assess:-
 - if there is any overprovision of private hire cars in each zone of South Lanarkshire
 - if there is any significant unmet demand in respect of taxis in each zone of South Lanarkshire
 - the sufficiency of Wheelchair Accessible Vehicles throughout the zones in South Lanarkshire

3. Background

- 3.1. Section 10(3) of the Civic Government (Scotland) Act 1982 provides that a Licensing Authority may refuse the grant of a taxi licence for the purpose of limiting the number of taxis in respect of which licences are granted by it, but only if it is satisfied that there is no significant unmet demand for the services of taxis in its area.
- 3.2. This provision did not apply to applications for private hire car licences. However, amendments made to the Act by the Air Weapons and Licensing (Scotland) Act 2015, which came into effect on 15 May 2017 introduced the concept of refusing applications for private hire cars on the basis of overprovision.
- 3.3. Sections 10 (3A), (3B) and (3C) of the Civic Government (Scotland) Act 1982 allow a Licensing Authority to refuse to grant an application for a private hire car licence on the grounds that it is satisfied that there already exists, or would exist if the licence was granted, an overprovision of private hire cars in the locality or localities in which the private hire car is to operate.

- 3.4. There is currently no statutory guidance available, however, the Scottish Government are in the process of drafting appropriate guidance.
- 3.5. In considering whether there is, or would be, an overprovision of private hire cars in the locality, Section 10(3C) provides that a Licensing Authority must have regard to the number of private hire car licences operating and the demand for private hire car services in the locality. Currently there is no evidence upon which the Licensing Authority could base a conclusion of unmet demand in any of its localities and the survey is proposed to address this.
- 3.6. An independent survey has not been carried out in respect of taxis for a number of years. Therefore, it is appropriate that this survey also look at the use and demand of taxis in each zone to determine if there is "any significant unmet demand" in respect of taxis.
- 3.7. There have always been questions raised as to the sufficiency of Wheelchair Accessible Vehicles throughout South Lanarkshire's area. It would therefore be appropriate to include this question in any survey to be carried out to assess the provision, use and demand of both taxis and private hire cars.

4. Employee Implications

4.1. There are no implications for employees arising from this report.

5. Financial Implications

5.1. The cost of the survey would require to be met from the existing Licensing budget.

6. Other Implications

- 6.1. The risk to the Council is that it fails to fulfil its duty to protect the public.
- 6.2. There are no apparent implications in terms of sustainable development.

7. Equality Impact Assessment and Consultation Arrangements

- 7.1. There is no requirement to carry out an impact assessment in terms of the proposals contained within this report.
- 7.2. The survey when it is being carried out will take into account views from, for example the trade, local residents, community councils and organisations representing disabled residents.

Civic Government (Scotland) Act 1982 (As Amended) - Sexual Entertainment Venues

1. Purpose of Report

1.1. The purpose of the report is to:-

 advise the Committee of the introduction of the licensing of sexual entertainment venues as a defined activity under the Civic Government (Scotland) Act 1982 (as amended)

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
 - (1) that a consultation exercise being carried out prior to a decision being made as to whether or not sexual entertainment venues should be licensed.

3. Background

3.1. The Civic Government (Scotland) Act 1982 has been amended by Section 76 of the Air Weapons and Licensing (Scotland) Act 2015. This section came into force on 29 April 2019. The licensing of sexual entertainment venues has been introduced as an optional activity which means that it is a matter for the licensing authority to decide whether or not it wishes to include such venues in the licensing regime. If the licensing authority decide to licence sexual entertainment venues then they will require to pass a resolution in order for this activity to be licensed in South Lanarkshire.

4. Present Position

- 4.1. Currently, as far as we are aware, there are no sexual entertainment venues within South Lanarkshire. However, the Committee may wish to consider whether they will wish to control these activities, even if no such premises are currently in operation in the Council area. If the licensing authority decides not to license the activity, then no licence will be required to operate a sexual entertainment venue within South Lanarkshire Council area in the future. This would mean that sexual entertainment venues would remain largely unregulated. If such a resolution is passed, any existing or new venues would require to be licensed.
- 4.2. The definition of a sexual entertainment venue is contained in the legislation. This defines the type of entertainment which is covered as well as other criteria for bringing premises within the ambit of the legislation.

- 4.3. Prior to considering whether or not to introduce a resolution, the licensing authority should carry out a consultation exercise. Such a consultation exercise would include members of the public, local businesses, Council Resources and Police Scotland (although this list is not exhaustive).
- 4.4. If the licensing authority decides to introduce a licensing regime for sexual entertainment venues, they must then determine the appropriate number of sexual entertainment venues for their area or relevant locality which can in fact be nil. Once the resolution has been passed the licensing authority can refuse the application on the grounds that at the time the application is determined the number of sexual entertainment venues in the local authority's area or relevant locality is equal to or exceeds the number that the authority considers appropriate for their area or that locality.

5. Employee Implications

5.1. None.

6. Financial Implications

6.1. If, after the consultation exercise is completed, the licensing authority agree to introduce licensing controls in respect of this activity, then a fee will be charged for each application.

7. Other Implications

- 7.1. The risk to the Council is that it fails to fulfil its duty to protect the public. This is mitigated by the application process which will be put in place should the Committee decide to introduce above licensing controls.
- 7.2. There will be implications for potential operators of sexual entertainment venues if licensing controls are introduced.
- 7.3. There are no apparent implications in terms of sustainable development.

8. Equality Impact Assessment and Consultation Arrangements

8.1. The recommendation at 2.1 above is to commence a consultation exercise throughout South Lanarkshire.
