3 Roads and Transportation Services - Roads Investment Programme - Progress Report

A report dated 17 November 2009 by the Executive Director (Enterprise Resources) was submitted on the progress of the Roads Investment Programme in the Cambuslang and Rutherglen area. Details were provided on the:-

- ♦ phasing of the additional £126 million expenditure on the Roads Investment Programme from 2008 to 2016
- ♦ level of expenditure allocated to each Council area including confirmation that £16.38 million would be spent in Cambuslang and Rutherglen over the 8 year programme
- ♦ increased expenditure on footways/footpaths
- ♦ priority scoring system for carriageway and footway/footpath schemes
- ♦ progress made in relation to the schemes within the Cambuslang and Rutherglen area which showed that 41 schemes had been completed or were programmed to be completed by the end of March 2010
