# 8 Civic Government (Scotland) Act 1982 (As Amended) - Application for Grant of Taxi Operator Licences

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and represented by N McShane, Solicitor. An objection had been received from Police Scotland and Sergeant Brown was heard.

#### The Committee decided:

that the 3 applications by South Lanarkshire Private Hire and S Harper, 24 Main Street, Bothwell for the grant of taxi operator licences in the Hamilton zone be granted.

## 9 Civic Government (Scotland) Act 1982 (As Amended) - Consideration of Suspension or Revocation of Private Hire Car Operator Licence No 731 and Private Hire Car Driver Licence No 727

A report dated 9 November 2023 by the Executive Director (Finance and Corporate Resources) was submitted proposing that consideration be given to whether private hire car operator's licence No 731 and private hire car driver's licence No 727 should be suspended or revoked.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the licence holder who was present and represented by N McShane, Solicitor. A letter of complaint had been received from Police Scotland and Sergeant Brown was heard.

#### The Committee decided:

that private hire car operator's licence No 731 in the Hamilton zone and private hire car driver's licence No 727 in the Cambuslang and Rutherglen zones be not suspended.

# 10 Civic Government (Scotland) Act 1982 (As Amended) - Application for Grant of Private Hire Car Driver's Licence

A report dated 9 November 2023 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. A representation had been received from Police Scotland and Sergeant Brown was heard.

that the application by K Igbinovia, 23 Luss Brae, Hamilton for the grant of a private hire car driver's licence in the Hamilton zone be granted for a period of one year.

# 11 Civic Government (Scotland) Act 1982 (As Amended) - Application for Grant of Private Hire Car Driver's Licence

A report dated 9 November 2023 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

The Council's Solicitor intimated that the applicant had been given the deadline of Friday 24 November 2023 to pass his route test. All applicants were required to pass a route test before a licence could be granted. As the applicant had failed to pass the route test by the deadline date, the application had to be refused.

#### The Committee decided:

to note that the application by A Ndoumbe Mboue, 54 to 57 Laurel Street, Glasgow for the grant of a private hire car driver's licence in the Cambuslang and Rutherglen zone had been refused as he failed to pass his route test.
