1 Declaration of Interests

2 Minutes of Previous Meeting

The minutes of the meeting of the Licensing Committee held on 24 August 2011 were submitted for approval as a correct record.

4 Civic Government (Scotland) Act 1982 - Licensing of Places of Public Entertainment

A report dated 5 September 2011 by the Executive Director (Finance and Corporate Resources) was submitted on an amendment to the existing Resolution for the Licensing of Places of Public Entertainment to take account of changes to the Civic Government (Scotland) Act 1982 which had been introduced by the Criminal Justice and Licensing (Scotland) Act 2010.

The Gambling Act 2005 now regulated establishments which were formerly regulated by way of a Public Entertainment Licence. Consequently, there was no longer any requirement for certain activities such as amusement arcades to be included in the Council's Public Entertainment Resolution. It was, therefore, proposed to delete any reference to those from the current Resolution.

The Criminal Justice and Licensing (Scotland) Act amended the current provision so that the words "on payment of money or money's worth" were deleted. The result of this amendment would be that all forms of public entertainment referred to in the Resolution must hold a Public Entertainment Licence before the event could take place. It was proposed, however, to amend the Resolution to specifically exclude "fetes and other events which were run purely for charitable purposes for which there was no charge for entry".

The amendments to the Civic Government (Scotland) Act 1982 would come into force on 1 April 2012.

In terms of Section 9 of the Civic Government (Scotland) Act 1982, appropriate notice for a statutory period of 28 days would require to be given in the press. On completion of that process, a further report requesting approval of the Final Resolution on Licensing of Places of Public Entertainment would be submitted to this Committee.

The Committee decided:

- (1) that the amendments to the Civic Government (Scotland) Act 1982 be noted; and
- (2) that the draft Resolution for the Licensing of Places of Public Entertainment, as detailed in the appendix to the report, be approved.

5 Civic Government (Scotland) Act 1982 - Licensing of Taxis - Review of Taxi Fares

A report dated 5 September 2011 by the Executive Director (Finance and Corporate Resources) was submitted advising on action taken, in terms of Standing Order No 36(c) in view of the requirement to progress the fares review in the Rutherglen and Cambuslang zone within the required timescales, by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member, to amend the fares increase in the Rutherglen and Cambuslang zone to £4.80 for a 2 mile hire.

On 24 August 2011, the Licensing Committee had agreed that the fares review in the Rutherglen and Cambuslang zone be progressed in line with the proposals detailed in an appendix to the report. However, in view of the fact that the wrong figure had been reported, the Chair, in terms of Standing Order No 17, had agreed that further consideration be given to the matter.

The increased fare over the 2 mile hire for the Rutherglen and Cambuslang zone was now £4.80 and not £4.60 as previously reported.

The Committee decided: that the action taken, in terms of Standing Order No 36(c), by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member, to agree that the fares review be progressed in the Rutherglen and Cambuslang zone based on a 2 mile hire of £4.80, be noted.

10 Civic Government (Scotland) Act 1982 - Licensing of Street Traders - Suspension of Licence

A report dated 5 September 2011 by the Executive Director (Finance and Corporate Resources) was submitted proposing that consideration be given to whether street trader's licence No 7 should be suspended in terms of Paragraph 11 of Schedule 1 of the Civic Government (Scotland) Act 1982.

It was agreed that the petition contained within the agenda papers was not relevant and should not be considered.

In terms of the Act, the opportunity of a hearing had been offered to the licence holder who was present and represented by Mr Devine, Solicitor who was heard in support of the licence holder retaining his licence. A representation had been received from Strathclyde Police and Sergeant Anderson and Inspector Ritchie were heard.

Councillor Devlin, seconded by Councillor Filshie, moved that the licence be not suspended. Councillor McLachlan, seconded by Councillor Baxendale, moved as an amendment that the licence be not suspended but that it be amended to remove the location of Lauder Drive. On a vote being taken by a show of hands, 7 members voted for the amendment and 11 for the motion which was declared carried.

The Committee decided: that street trader's licence No 7 be not suspended.
