### 3 Application EK/10/0056 - Mixed Use Development Comprising Class 1 Superstore, Garden Centre, Hotel, Class 3 Uses, Petrol Filling Station, Allotments, Landscaping, Associated Access and Car Parking (Planning Permission in Principle) at Land at Redwood Crescent, Peel Park, East Kilbride

The Head of Legal Services advised that Dawn Developments Limited had lodged a petition for Judicial Review with the Court of Session seeking:-

- ♦ a court decision requiring the Planning Committee to consider planning application EK/10/0056 by JHAG Limited for a mixed use development comprising Class 1 superstore, garden centre, hotel, Class 3 uses, petrol filling station, allotments, landscaping,

associated access and car parking (planning permission in principle) at land at Redwood Crescent, Peel Park, East Kilbride and planning application EK/10/0110 by Dawn Developments Limited for the erection of a Class 1 retail superstore with associated car parking and landscaping at West Mains Road, East Kilbride at the same Planning Committee meeting

- ♦ an interim interdict against the Planning Committee considering planning application EK/10/0056 by JHAG Limited at its meeting on 22 June 2010

The Head of Legal Services further advised that the Council did not believe that it was required to consider both applications at the same meeting but had given an undertaking not to consider planning application EK/10/0056 by JHAG Limited at the Planning Committee meeting on 22 June 2010 to allow the issues to be canvassed fully before a Judge.
