5.1. The total capital programme for Corporate Resources for 2007/2008 is £1.603million. Anticipated spend to date was £0.572million, with £0.598million expenditure incurred (37.31% of full budget). This represents a position of £0.026million ahead of profile. This time last year £0.409million was spent (40.82%).
