1 Declaration of Interests

2 Recommendations Referred by Executive Committee - Housing Revenue Account Budget and Capital Programme 2010/2011; and Revenue Budget and Level of Local Taxation 2010/2011

A report dated 11 February 2010 by the Chief Executive was tabled on recommendations referred to the Council by the Executive Committee (Special) of 11 February 2010. The recommendations were as follows:-

♦ Housing Revenue Account Budget and Capital Programme 2010/2011

that the recommendations of the Housing and Technical Resources Committee (Special) in relation to the Housing Revenue Account Budget 2010/2011 and Housing Capital Programme 2010/2011 be approved.

♦ Revenue Budget and Level of Local Taxation 2010/2011

- that the recommendation of the Finance and Information Technology Resources Committee (Special) and the Revenue Budget for 2010/2011 be approved;
- that the re-allocation of budget in respect of Concordat commitments, as detailed in the report, including the allocation of £1.670 million to the Winter Maintenance Programme and £1.000 million to Teachers' Maternity Pay, be approved;
- that the budget allocations for each Resource, as detailed in the appendix to the report, be approved;
- ♦ that the Band D Council Tax for 2010/2011 be set at a figure of £1101;
- that the actions required to finalise the Council's detailed Revenue Budget for 2010/2011 be approved; and
- that, in line with good governance arrangements, the Council's policy objectives and performance continue to be reviewed at Service, Resource and corporate levels.

Councillor McAvoy, seconded by Councillor McCann, moved that the recommendations detailed in the report be approved. Councillor Allison, seconded by Councillor Murray, moved as an amendment that the recommendation in relation to the re-allocation of budget in respect of Concordat commitments be not accepted on the grounds that Early Years' provision had more value than the reduction of class sizes. On a vote being taken by a show of hands, 6 members voted for the amendment and 56 for the motion which was declared carried.

Councillor McAvoy:-

- ♦ made a statement highlighting the priorities within the 2010/2011 Revenue Budget
- advised that, in light of the current economic climate, members' seminars would take place throughout the year to allow consideration of the potential difficulties to be faced by the Council in future years

Both the Leader of the Council and the Leader of the Opposition acknowledged the contribution of officers to the budget process and extended thanks to Councillor Watters, in his capacity as President of the Convention of Scottish Local Authorities (COSLA), for his valuable input in relation to the budget negotiations at a national level.

The Council decided:
