1. Purpose of Report

3. Background

3.1. As part of the Council's performance management arrangements, regular Workforce Monitoring Reports are submitted to Committee. This report for Finance and Information Technology Resources provides information on the position for June, July and August 2009.

4. Monitoring Statistics

4.1. Attendance Statistics (Appendix 1)
Information on absence statistics are analysed for the most recent month of August 2009 for Finance and Information Technology Resources.

The Resource absence figure for August 2009 was 1.8%, showing a decrease of 0.3% from last month and is 1.4% lower than the Council Wide figure. Compared to August 2008 the Resource absence figure has decreased by 0.2%.

Based on annual trends and the period August 2009, the annual average figure for the Resource equates to 2.2% as against a Council wide average of 4%.

For the Resource this equates to 5 days being lost per employee for the year due to absence compared with the figure for the Council of 8.6 days per employee.

4.2 Occupational Health (Appendix 2)

In terms of referrals to occupational health, which include medical examinations and physiotherapy, overall 17 referrals were made this period, an increase of 4 when compared with the same period last year.

4.3 Accident/Incident Statistics

There were no accidents/incidents recorded within the Resource this period, a decrease of 3 when compared with the same period last year.

4.4 Discipline, Grievance and Dignity at Work

There were no disciplinary hearings, grievances or dignity at work cases held within the Resource this period.

4.5 Analysis of Leavers

There were no leavers in the Resource this period, a decrease of 7 when compared to the same period last year.

5 Staffing Watch

5.1 There has been an increase of 1 employee in post since from 8 March 2009 to 13 June 2009.
