3 Education Scotland Report - St Charles' Primary School, Cambuslang

A report dated 13 August 2018 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of St Charles' Primary School, Cambuslang by Education Scotland inspectors.

The inspection had taken place in December 2017 as part of a national sample of primary education and the inspection letter reporting on the findings had been published on 15 May 2018.

A number of particular strengths of the school had been identified in the inspection letter. The areas for improvement, agreed with the school and education authority, had been incorporated into the school's improvement plan and parents would be informed of progress. Education Scotland had intimated that they would make no further visits in connection with this inspection.
