Subject: School Holiday Dates for Session 2011/2012

1. Purpose of Report

- 1.1. The purpose of the report is to:-
 - ◆ consider the proposed dates for school holidays in South Lanarkshire for session 2011/2012 following a consultation with stakeholders.

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that the proposed dates for school holidays in South Lanarkshire for session 2011/2012, as detailed in Appendix 1, be approved.

3. Background

- 3.1. Children are required to attend school for 190 days with teachers working 195 days, five of which are deemed in-service days. However, it should be noted that the Government has proposed that there is an additional national holiday in June 2012 to mark the Queen's Diamond Jubilee.
- 3.2. The school holiday dates normally fall within 3 terms and take account of national/local public holiday dates,
 - Term 1 from the beginning of the school year in August until Christmas;
 - Term 2 from the new year through until the spring break;
 - Term 3 from after the spring break until the end of the school year in June.
- 3.3. Views were sought from a range of stakeholders on the proposed school holiday dates for 2011/2012 including neighbouring local authorities to try and achieve, where possible, a common pattern of school holiday dates across Lanarkshire for the benefit of parents and schools. The Scottish Government also asked that local authorities give consideration to designating St Andrew's Day as a school holiday. This would not be an additional day as is being proposed for the Queen's Diamond Jubilee but a day that would require to taken from the existing core pattern of holiday dates. Further details on this are provided in paragraph 4.3 of this report.
- 3.4. Arrangements were made also to consult with establishments, Parent Councils and employees through the Joint Negotiating and Consultative Committee (JNCC) for teachers and the Joint Consultative Committee (JCC) for Administrative, Professional, Technical and local Government employees.

4. Consultation Outcome

4.1. The outcome of the consultation with establishments, parents, Parent Councils and other stakeholders that resulted in 350 responses being made to this particular part of the consultation is as follows:

The JNCC for teachers and the JCC for APT&C employees agreed with the proposed dates for 2011/2012.

- 4.2. A range of comments were also made by consultees on the proposed school holiday dates including views on the proposals for the change to the May holiday weekend to accommodate the additional national holiday in 2012 to mark the Queen's Diamond Jubilee.
- 4.3. During the consultation, consultees where asked for their views on whether, in the future, St Andrew's Day on 30 November should be designated as a school holiday. Over 330 responses were made on-line to this particular part of the consultation. There was no clear consensus of opinion and a variety of views expressed including some that highlighted that children and young people benefit more by actively engaging in activities to celebrate St Andrew's Day in school. It is proposed, therefore, to continue to have further dialogue with stakeholders.

5. Proposal

- 5.1. Of the stakeholders consulted, the majority agreed with the proposed holiday dates. It is proposed, therefore, that the pattern for the school holidays for the 2011/2012 session, as highlighted in Appendix 1, be adopted. The arrangements set out are generally in line with neighbouring authorities.
- 5.2. Teachers will return to two in-service days (Monday 15 August 2011 and Tuesday 16 August 2011) with the remaining 3 in-service days agreed locally following consultation with schools and trades unions. Pupils return on Wednesday 17 August 2011.
- 5.3. In 2011/2012, the Good Friday (6 April) and Easter Monday (8 April) holiday dates fall within the Spring break which takes place in the first two weeks in April.
