# 4 Civic Government (Scotland) Act 1982 - Licensing of Taxi Drivers - Consideration of Suspension of Licence

A report dated 12 April 2007 by the Executive Director (Corporate Resources) was submitted:-

- advising on action taken, in terms of Standing Order No 36(c) due to the timescales involved, by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member, to suspend taxi driver's licence No 21 held by J Geddes, 34 Bankhead Terrace, Lanark
- proposing that consideration be given to whether taxi diver's licence No 21 should be suspended

In terms of the Civic Government (Scotland) Act 1982, the opportunity of a hearing had been offered to the licence holder, J Geddes, who was not present or represented. An objection by Strathclyde Police was heard.

### The Committee decided:

- (1) that taxi driver's licence No 21 for the Clydesdale zone held by J Geddes, 34 Bankhead Terrace, Lanark be suspended with immediate effect for the remainder of the period of licence; and
- (2) that the action taken, in terms of Standing Order No 36(c), by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member to suspend taxi driver's licence No 21 held by J Geddes, 34 Bankhead Terrace, Lanark, be noted.

# 5 Civic Government (Scotland) Act 1982 - Licensing of Taxi Drivers - Consideration of Suspension of Licence

A report dated 12 April 2007 by the Executive Director (Corporate Resources) was submitted:-

- advising on action taken, in terms of Standing Order No 36(c) due to the timescales involved, by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member, to suspend taxi driver's licence No 200 held by D Ramage, 22 Morgan Street, Larkhall
- proposing that consideration be given to whether taxi driver's licence No 200 should be suspended

In terms of the Civic Government (Scotland) Act 1982, the opportunity of a hearing had been offered to the licence holder, D Ramage, who was not present or represented. An objection by Strathclyde Police was heard.

A written request received from D Ramage's solicitor that consideration of the suspension of the licence be postponed to allow further contact with their client was rejected by the Committee on the basis that this would contravene statutory timescales for considering the suspension.

# The Committee decided:

- (1) that taxi driver's licence No 200 for the Hamilton zone held by D Ramage, 22 Morgan Street, Larkhall be suspended with immediate effect for the remainder of the period of licence; and
- (2) that the action taken, in terms of Standing Order No 36(c), by the Executive Director (Corporate Resources), in consultation with the Chair and an ex officio member, to

suspend taxi driver's licence No 200 held by D Ramage, 22 Morgan Street, Larkhall, be noted.
