Subject: Delegated Powers Report – Update

1 Purpose of Report

- 1.1 The purpose of the report is to:-
 - advise the Estates Committee of the transactions processed by delegated authority during the period 1 October to 31 December 2005 by Estates and Regeneration Services.

3 Background

3.1 The Head of Estates and Support Services has delegated powers to deal with lease transactions of a value up to £50,000 per annum and a maximum period of 10 years and capital transactions up to a value of £150,000.

4 Volume of Transactions 3rd Quarter 2005/06

4.1 Appendix 1 shows the transactions for the period 1 October to 31 December 2005.

Total number of transactions this quarter 82

Total value of lease transactions this quarter £360,633 per annum

Total value of capital transactions this quarter £529,166

- 4.2 The majority of lease transactions relate to the granting of new leases (27 out of 51).
- 4.3 Of the 18 disposal transactions 13 were garden ground, one was an industrial site and the most significant sale was a house at 116 Glenfruin Road, Blantyre at a value of £72,350.
- 4.4 Of the seven acquisitions three were the purchase of dwellings in association with the Fernhill Regeneration Proposals and two were in respect of the improvements to Greenhills Road, East Kilbride.

- 6.1 The rental income to the Council is increased as a result of the new lettings and rent reviews.
- 6.2 The disposals generate additional capital monies for the Council's Capital Programme.
