### 6 Inspection of Social Work Resources by the Social Work Inspection Agency (SWIA)

A report dated 17 May 2006 by the Executive Director (Social Work Resources) was submitted on an Action Plan which had been developed to address the Social Work Inspection Agency's (SWIA) 15 recommendations following completion of their inspection of Social Work Resources.

The Action Plan was detailed in the appendix to the report and set out the various targets and responsibilities for achieving those. Arrangements would be put into place to monitor progress and reports would be submitted to this Committee on a 6 monthly basis.

- (1) that the Action Plan to address the recommendations made by SWIA following their inspection of Social Work Resources, as detailed in the appendix to the report, be approved; and
- (2) that 6 monthly progress reports on the Action Plan be submitted to this Committee.

#### 7 Social Work Inspection Agency (SWIA) Performance Inspection of Lanarkshire Criminal Justice Grouping

A report dated 24 May 2006 by the Executive Director (Social Work Resources) was submitted on a Performance Improvement Plan which had been developed to address the Social Work Inspection Agency's (SWIA) recommendations following completion of their performance inspection of Lanarkshire Criminal Justice Grouping. The Performance Improvement Plan was detailed in the appendix to the report and set out the various targets and responsibilities for achieving those. Arrangements would be put in place to monitor progress and a 6 monthly progress report would be submitted to this Committee.

#### The Committee decided:

- (1) that the Performance Improvement Plan to address the recommendations made by SWIA, following their inspection of Lanarkshire Criminal Justice Grouping, as detailed in the appendix to the report, be approved; and
- (2) that a 6 monthly progress report on the Performance Improvement Plan be submitted to this Committee.

#### 8 PAMIS (Promoting a More Inclusive Society) - Healthy Lifestyles Project

A report dated 3 May 2006 by the Executive Director (Social Work Resources) was submitted on the Council's involvement in the PAMIS (Promoting a More Inclusive Society) Healthy Lifestyles Project. PAMIS offered a service to children and adults with profound and multiple learning disabilities through providing support for their carers.

It was proposed that this Council make a contribution of £15,000 to the Healthy Lifestyles Project in each of the next 3 financial years. The Project would be funded from a successful application to the Big Lottery Fund for funding of £226,330 and from contributions from 6 local authority/health board partners of £15,000 each per annum over the 3 year period of the project.

The Committee decided:

that £15,000 be contributed to the PAMIS Healthy Lifestyles Project in each of the next 3 years.

#### 9 East Kilbride Befriending Project

A report dated 22 May 2006 by the Executive Director (Social Work Resources) was submitted on the negotiation of a contract for the provision of a Befriending Service in East Kilbride.

In terms of Standing Order No 12.5 of the Standing Orders on Contracts, it was proposed to negotiate a 3 year contract with the East Kilbride Befriending Project for the provision of a befriending service in the sum of £52,000 per annum.

#### **10 Tender for Stairlifts**

A report dated 5 June 2006 by the Executive Director (Social Work Resources) was submitted on the award of a contract for the installation, servicing and repair of stairlifts.

It was proposed that the contract for the installation, servicing and repair of stairlifts be awarded to Advanced Stairlift Scotland Limited for the period 1 June 2006 to 31 May 2008, with an option to extend for 1 year, in the sum of £1.2 million per annum.

# **The Committee decided:** that the Executive Director (Social Work Resources) be authorised to enter into a 2 year contract with Advanced Stairlift Scotland Limited for the installation, servicing and repair of stairlifts for the period 1 June 2006 to 31 May 2008, with an option to extend for 1 year, in the sum of £1.2 million per annum.

#### **11 Authorised Providers List - Social Care**

A report dated 16 May 2006 by the Executive Director (Social Work Resources) was submitted on the amendment to 2 providers on the Authorised Providers List for Social Care to include additional service type.

The accreditation process had been completed for the 2 providers who had both met the relevant criteria.

that the entry for the 2 organisations detailed below on South Lanarkshire Council's Authorised Providers List for Social Care be amended to include additional service type:-

#### 12 Reporting of 'Call Off' Contracts Negotiated with Authorised Providers

A report dated 16 May 2006 by the Executive Director (Social Work Resources) was submitted on a 'Call Off' contract negotiated with an Authorised Provider and awarded by Social Work Resources in the period May and June 2006.

In terms of Standing Order No 12.4 of the Standing Orders on Contracts, Social Work Resources were required to notify the relevant Committee of 'Call Off' contracts that had been awarded to Care Home and Homecare Providers. Details of the contract awarded were provided in the report.

#### **13 Charter Mark Status**

A report dated 7 June 2006 by the Executive Director (Social Work Resources) was submitted on the achievement of Older People's Day Care Services within Social Work Resources in gaining Charter Mark status.

Charter Mark status was a nationally recognised standard of customer service which recognised excellence in public services. Older People's Day Care Services had been awarded Charter Mark status for a period of 3 years at the end of which it would be subject to a full reassessment.

#### 14 Care Accolade Awards 2006

A report dated 6 June 2006 by the Executive Director (Social Work Resources) was submitted on the success of Social Work Resources in gaining 2 Care Accolade Awards which had been awarded on 2 June 2006.

The Scottish Social Services Council had invited social care services to apply for the Care Accolade Awards 2006. The awards had been established in 2004 to recognise and promote good practice across the care sectors. Social Work Resources had received the awards for excellence in the categories of recruitment and retention and developing learning opportunities.
