4 Notification of Intention to Hold Public Procession in Hamilton on 6 July 2007 – Hamilton LOL 241

The Panel considered an observation by Strathclyde Police on a notification of intention to hold a public procession on 6 July 2007 in Hamilton submitted by Hamilton LOL 241.

C Cefferty, R Cook and D Hannah, representing Hamilton LOL 241, and Superintendent Callander and Inspector Lindsay, representing the Chief Constable, were present at the meeting. All parties were heard in relation to the public procession.

The Panel decided:

- (1) that no order be made to prohibit the public procession from taking place subject to the route being amended as follows:-

- ◆ Parade assembles at 1845 hours on Farm Road at Farm Terrace, then on to Farm Road, Mayfield Street, Hill Street, Milton Street, Sempie Street, Waverley Street, Farm Road, Udston Road, High Blantyre Road, Glasgow Road, Purdie Street, Wilson Street where parade will disperse
- (2) that the public procession permit be issued with an additional condition relating to the amended route.

5 Notification of Intention to Hold Public Procession in Cambuslang on 11 August 2007 – Crimson Arrow Royal Black Preceptory 590

The Panel considered an observation by Strathclyde Police on a notification of intention to hold a public procession on 11 August 2007 in Cambuslang submitted by Crimson Arrow Royal Black Preceptory 590.

T Black, representing Crimson Arrow Royal Black Preceptory 590, and Inspector Lindsay, representing the Chief Constable, were present at the meeting. All parties were heard in relation to the public procession.
