Planning Application Report

1 Application Site

1.1 The application site relates to an area of ground forming a grass verge adjacent to a section of public footway on the north side of Cathkin Bypass. The application site is bounded to the north by a hedge with a road and residential properties beyond, open space to the east and west and by a road, hedge, further road and residential properties beyond to the south.

2 Proposal

2.1 The applicant seeks detailed planning permission for the erection of a 15m telecommunications monopole with 3 no. antennas and associated equipment cabinet.

3 Background

3.1 Local Plan Status

- 3.1.1 The South Lanarkshire Local Plan (adopted) provides the development plan context for this application. The application site lies within an area covered by Policy RES6 Residential Land Use. Policy RES6 states that the Council will resist any development that will be detrimental to the amenity of residential areas and that the development must relate satisfactorily to the surrounding environment.
- 3.1.2 Policy DM1 Development Management states that all planning applications should take account of the local context and built form and that all development should be compatible with adjacent buildings and surrounding streetscape in terms of scale, massing, design, external materials and impact on amenity.
- 3.1.3 Policy DM12 Telecommunications Development is of particular importance in relation to this application. This policy states that in assessing telecommunications proposals, the Council will require to take account of the impact on visual amenity, character and appearance of the surrounding area and minimise environmental and visual impact through the exploration of a range of options including concealment/disguise, the use of small scale antennas/equipment and the use of innovative design.

3.2 Relevant Government Advice/Policy

- 3.2.1 The Scottish Government supports the expansion and diversification of the telecommunications industry, but recognises that this must be done sensitively to safeguard our natural and built environment. Government guidance with regards the siting and design of telecommunication apparatus is set out within Scottish Planning Policy (SPP) (February 2010) which supersedes National Planning Policy Guidance Note 19 (NPPG 19) Radio Telecommunications and Planning Advice Note 62 (PAN62) Radio Telecommunications.
- 3.2.2 In terms of the current SPP this policy guidance advises that all new development should be sited and designed to minimise visual impact. It is advised that this may be achieved by following the series of options below: -
 - Installation of smallest suitable equipment,
 - Concealing and disguising masts, antennas, equipment housing and cable runs, using design and camouflage techniques,
 - Mast or site sharing,
 - Installations on buildings and existing structures, and
 - Installation of ground based masts.

3.3 <u>Planning History</u>

3.3.1 There are no records of any applications at this site within the last ten years.

4 Consultation(s)

- 4.1 <u>Rutherglen Community Council</u> object to the proposal due to health concerns of the mast and the vicinity to Cathkin Primary School.
 <u>Response</u>: Noted. This issue will be addressed within section 5 of the report.
- 4.2 **<u>Burnside Community Council</u>** object to the proposal due to it having a negative impact on the local environment as it will be conspicuous and tower over the wider area. The proposed location is within a sensitive residential area and safety fears over the mast also expressed.

Response: Noted. These issues will be addressed within section 5 of the report.

4.3 **<u>Roads and Transportation Services</u>** – raised no objections to the proposal. <u>**Response:**</u> Noted

5 Representation(s)

- 5.1 Following statutory neighbour notification and advertisement in the Rutherglen Reformer for non-notification of neighbours, 452 letters of representation have been received for this application. The main points are as follows:
- a) The proposed mast is located within a streetscene as described in Policy DM12 and is in no way designed to "minimise its impact on the appearance of the streetscene" as it is set away from the hedge by being placed on the kerbside meaning that the mast and both boxes are plainly visible to passers by. The mast will tower above the trees along the avenue and will stick out like a sore thumb.

Response: The mast has been designed to appear as an element of street furniture. It is felt that the mature trees and hedge to the rear of the proposed mast and equipment cabinets will provide an effective backdrop which will help to integrate the development with its surroundings. All development is visible to some degree and an assessment is made on the basis of integration with the locale. In this instance, a wide road and high hedge provides a barrier to nearby residential properties.

b) The proposed mast will be in everyone's eyeline and will impact on the views from nearby properties.

<u>Response</u>: The right to a view is not a material planning consideration in the assessment of this application.

c) The proposed mast would adversely impact on the value of residential properties in the surrounding area as people are still apprehensive about mobile phone masts.

<u>Response</u>: The impact on property values as a result of any proposed development does not constitute a material planning consideration in the assessment of this planning application.

- d) The mast and equipment will be a target for vandals.
 <u>Response</u>: This is not a material planning consideration. Vandalism is a matter for the police.
- e) It is regarded that the trees present will not provide an adequate screen for the development as they only have leaves for 6 months of the year with the mast therefore being highly visible and even more of an eyesore on a busy road.

<u>Response</u>: Although the trees will be bare of leaves for part of the year, it is felt that the tree structure will still provide a backdrop for the mast and that the hedge will screen the equipment cabinet.

f) The proposal is located in a "sensitive site" as outlined in Policy DM12 and is therefore not in accordance with said policy.
 <u>Response:</u> The application site can be classed as a "sensitive" site due to the proximity of residential properties. However, this does not preclude the siting of a mast. It is regarded that the trees and high hedge present on site provide an

effective screen to nearby residential properties.

g) There is concern about pedestrian safety as the pavement is very narrow and with the equipment cabinet installed, it will become impossible for 2 pedestrians to pass each other at that point. This is a busy footpath where people with double buggies will be disadvantaged on their way to nearby schools and nurseries.

<u>Response</u>: Roads and Transportation Services raised no objections in relation to pedestrian safety following consultation. It is noted that the mast and monopole would be located on the grass verge rather than on the footpath meaning that the footpath would remain unchanged.

h) The Council carefully designed the landscaping on the Bypass to create a specific aesthetic character and this will be compromised by the proposal. The greenery and landscaping is regularly maintained by the Council showing how much they value the contribution to the aesthetic appearance of the area it makes.

Response: It is not regarded that the proposal would significantly detract from the aesthetics of the area as Cathkin Bypass is a relatively wide and long road with the proposed mast situated on one small part.

i) There is concern about the potential health risks to people in the surrounding residential area with the agent for the application referring to outdated World Health Organisation factsheets (304, May 2006 and 193, May 2010) whilst ignoring updated reports (factsheet 208, May 2011). The evidence on which Planning Department guidelines are based is now obsolete and should be adjusted accordingly.

Response: With regard to health risks, government advice is that there is no evidence to support these concerns. Subject to compliance with ICNIRP Public Exposure Guidelines, the government has further advised that this is not a material planning consideration. Recent research cannot be considered until the Scottish Government issues revised guidance in that respect. The proposed mast complies with the current ICNIRP guidelines.

j) The agent acting on behalf of O2/Vodafone had chosen a site close to the corner of Burnside Road (application site) and following pre application advice from South Lanarkshire Council were advised that it was too close to the corner. A site 50m east was then marked out. Following an article in the Rutherglen Reformer dated 8 June 2011 highlighting the fact that the proposed mast would be yards from the home of a woman suffering from a brain tumour, Mono (whilst not admitting to any health risk) opted to apply for planning permission at the site they had been advised against.

Response: A pre-application letter dated 21 April 2011 for a Telecommunications Mast at the current application site was received from Mono Consultants. A response from the Planning Service dated 13 May 2011 stated that a telecommunications mast at this location would be acceptable in principal. However,

it was asked that alternative sites further along the bypass be considered. It should be noted that this advice was given without prejudice to formal consideration by the Council of any subsequent planning application.

k) A planning application for a telecommunications mast was recently refused permission on Upper Bourtree Drive on the grounds that if approved it would set an undesirable precedent which could encourage similar applications to the detriment of the appearance and amenity of the area. Surely a greater consideration is the protection of vulnerable children?

<u>Response:</u> Planning Applications are assessed on their individual merits. As outlined in point i) above, issues relating to health are not currently treated as a material planning consideration.

These letters have been copied and are available for inspection in the usual manner and on the Planning Portal.

6 Assessment and Conclusions

- 6.1 The applicant seeks detailed planning permission for the erection of a 15m telecommunications monopole with 3 no. antennas and associated equipment cabinet. The main considerations in determining this application are its compliance with local plan policy, government guidance on telecommunications equipment, its impact on road/pedestrian safety and its impact on the amenity of the surrounding area.
- 6.2 Government guidance is set out within Scottish Planning Policy (February 2010) and Planning Advice Note 62 (PAN62) – Radio Telecommunications. Paragraphs 250 – 254 of Scottish Planning Policy and paragraphs 37-76 of PAN 62 relate to the siting and design of Telecommunication Equipment. They both advise that in selecting the site and design both operators and planning authorities should consider a series of options. The options are:
 - installing small scale equipment
 - concealment or disguising equipment
 - mast sharing
 - site sharing
 - installing on existing buildings or other structures; and
 - erecting new ground based mast.
- 6.3 In considering the options there must be regard to the cumulative effects of telecommunications masts. There is a need to think beyond individual proposals and consider how future telecommunications equipment will be integrated into the landscape.
- 6.4 It further advises that whilst antennas and other equipment can be disguised as street furniture, such as street lighting, such installations have to respect the townscape qualities of the area. I am of the opinion that the proposal does respect the existing street scene as the trees and high hedge in the surrounding area will provide an effective backdrop. There is also other street furniture present along the highway.
- 6.5 Paragraph 44 of PAN 62 relative to mast sharing, advises that conditions in the code systems operators' licences requires that the possibility of sharing an existing radio site be explored and that evidence of this should accompany planning applications. Supporting information states that given the predominantly residential nature of the target coverage area, that there are no suitable tall buildings or

structures existing that could accommodate the apparatus. Fernhill and Cathkin Parish Church was discounted due to the fact that the congregation turned down the approach and that the landlords consent could therefore not be obtained. A site on Burnside Road adjacent to Fernhill Road was discounted on the grounds that there are gas mains under the footpath with signs stating that no works to be carried out within 10m. Although the sign does not actually state this – it states that prior to commencement of any work on or within 10m of the site to telephone a contact number - it is felt that this site is more isolated and would be more visually intrusive. With regards to the provision of a ground based mast, whilst this is the last option in the series, government guidance advises that this does not mean that it will not be the best solution. The current proposal is part of the strategic partnership between Vodafone and 02 to share mobile assets in the U.K. Accordingly this proposal is considered to meet the criteria as no suitable alternative sites are readily available and the siting and external appearance of the apparatus is such that it should have minimal impact on amenity due to its design, location and backdrop of mature trees and hedging.

- 6.6 In terms of the South Lanarkshire Local Plan (adopted), Policies RES6 – Residential Land Use. DM1 – Development Management and DM12 – Telecommunications Development are applicable. Policy RES6 states that the Council will resist any development that will be detrimental to the amenity of residential areas and that the development must relate satisfactorily to the surrounding environment. Policy DM1 states that all planning applications should take account of the local context and built form and that all development should be compatible with adjacent buildings and surrounding streetscape in terms of scale, massing, design, external materials and impact on amenity. Although the proposal is located within an area outlined as Residential Land Use, it is regarded that the development is acceptable due to its location to the front of mature trees and a high hedge which will aid its integration with the surrounding area. Only the top of the proposal is in the direct view of residential properties (approximately 20m from these properties) and this is not deemed to significantly impact on their residential amenity. In this regard, the proposal is deemed to be in accordance with the aforementioned policies.
- 6.7 With regards to the Council's telecommunication policy, Policy DM12 of the South Lanarkshire Local Plan states that the Council should have regard to government policy and to local plan policies which seek to safeguard amenity and the environment. Although the application site is considered a 'sensitive site' due to being located within view of residential properties, this view is broken by mature trees and a high hedge. It is regarded that the distance from directly facing upper floors of residential properties is sufficient to not significantly impact on the residential properties and that the backdrop of mature trees and high hedge provides an effective screen, as outlined in paragraphs 6.5 and 6.6 above. The applicant has demonstrated that the site is the most appropriate location and that no suitable alternatives exist, as outlined in paragraph 6.5 above.
- 6.8 Whilst four hundred and fifty two letters of representation have been received for this application, it is regarded that none of the issues raised would justify the refusal of the current proposal.
- 6.9 The proposal satisfies the criteria set out within the Council's approved policies and the Government's guidance on telecommunications development and I therefore recommend that planning permission be granted.

7 Reasons for Decision

7.1 The proposal is in accordance with government guidance on the siting and design of telecommunications apparatus as detailed with Scottish Planning Policy and Planning Advice Guidance Note 62 – Radio Telecommunications. In addition, the proposal is in accordance with Policies RES6, DM1 and DM12 of the South Lanarkshire Local Plan (adopted) and the guidance notes contained therein.


