### 2 Minutes of Previous Meeting

### 3 Capital Budget Monitoring 2008/2009 - Housing and Technical Resources (HRA)

A joint report dated 7 January 2009 by the Executive Directors (Finance and Information Technology Resources) and (Housing and Technical Resources) was submitted advising of progress on the capital programme for Housing and Technical Resources (HRA) for the period 1 April to 23 December 2008.

The projected level of Council House and Land Sales income had been reviewed in light of the current economic downturn. The income from receipts was now estimated at £13.438 million, a reduction of £7.288 million. This would be managed by increasing the revenue contribution from £15.942 million to £20.037 million leaving a shortfall of £3.193 million to be met by prudential borrowing.

- (2) that the revised funding package for the Housing and Technical Resources (HRA) capital programme be noted.

# 9 Anti-social Behaviour Strategy 2009 to 2013

A report dated 9 January 2009 by the Executive Director (Housing and Technical Resources) was submitted on:-

- progress in developing South Lanarkshire's second Anti-social Behaviour Strategy for the period 2009 to 2013
- the arrangements for consultation on the draft Strategy

As part of the Anti-social Behaviour etc (Scotland) Act 2004, there was a requirement on both the Council and Strathclyde Police to prepare jointly an Anti-social Behaviour Strategy. The first South Lanarkshire Anti-social Behaviour Strategy had been approved in November 2004 and had covered the period up to 2008.

The new Strategy for the period 2009 to 2013 had been developed to ensure effective progress was achieved in relation to key national and local outcomes as set out in the South Lanarkshire Single Outcome Agreement. Details were provided on the key actions which supported the 4 strategic outcomes which provided the overarching focus for the Strategy as follows:-

Strategic Outcome 1 - "Safe and attractive communities in which people want to live"

**Strategic Outcome 2** - "A reduction in the impact which anti-social behaviour has on people's lives"

**Strategic Outcome 3 -** "Improved quality of advice, assistance and support for victims of antisocial behaviour and other service users"

**Strategic Outcome 4** - "Local communities have an effective input into the development and implementation of the strategy and local action planning"

Work on developing the second Strategy was nearing completion and the draft Strategy would be the subject of extensive consultation with service users, partner agencies and other interested parties from 9 February to 29 May 2009. The finalised Strategy would be submitted to Committee for approval at the appropriate time.

### The Committee decided:

- (1) that progress in developing South Lanarkshire's second Anti-social Behaviour Strategy be noted; and
- (2) that the draft Strategy be approved as the basis for consultation with a wide range of stakeholders in the period from 9 February to 29 May 2009.
