# 5 Establishment of South Lanarkshire Council Personal Protective Equipment Distribution Hub

A report dated 10 February 2021 by the Executive Director (Housing and Technical Resources) was submitted providing an update on the establishment of a South Lanarkshire Council Personal Protective Equipment Distribution Hub.

In recognition of the increased demand for Personal Protective Equipment (PPE) due to the COVID-19 pandemic, and the limited supply of the required equipment, the Council established an initial distribution hub at Newberry Rooney Day Centre, Hamilton in March 2020. The hub was designed to receive and distribute supplies of PPE to both the Council and private social care sector.

Following a review of the suitability of the Newberry Rooney Day Centre as a storage and delivery hub for PPE, it was agreed that a new hub be established in an industrial unit in Hamilton.

Details of the scale of the service delivery, provided by 12 employees from Housing and Technical Resources, was provided in the report.

The Chair and members of the Forum thanked M Cassidy and his team for their effort in providing a supply of PPE across the Council during a very challenging time.
