# Subject: Enterprise Resources - Capital Budget Monitoring 2010/2011

## 1. Purpose of Report

- 1.1. The purpose of the report is to:-
  - provide information on the progress of the capital programme for Enterprise Resources for the period 1 April 2010 to 18 February 2011.

## 2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):-
  - (1) that the Enterprise Resources capital programme of  $\pounds$ 27.440 million, and expenditure to date of  $\pounds$ 18.933 million be noted.

## 3. Background

- 3.1. This is the fourth capital monitoring report presented to the Enterprise Resources Committee for the financial year 2010/2011.
- 3.2. The report details the financial position for Enterprise Resources in Appendix A.

# 5. Financial Implications

5.1. The total capital programme for Enterprise Resources for 2010/2011 is £27.440 million. Anticipated spend to date was £23.063 million with £18.933 million of expenditure being incurred (69.00% of full budget). This represents a position of £4.130 million behind profile. This time last year £22.053 million was spent (71.54%).

# 6. Other Implications

6.1. The main risk associated with the Council's Capital Programme is failure to manage the projects resulting in a significant overspend. The risk has been assessed as low given the detailed project management plans prepared and monitored for each project. The risk of an overspend is managed through 4 weekly Investment Management Meetings.
