## 2 Minutes of Previous Meeting

#### 8 School Inspection Framework Review - Public Consultation

A report dated 19 October 2010 by the Executive Director (Education Resources) was submitted on the public consultation on proposals for Her Majesty's Inspectorate of Education (HMIe) school inspection framework.

The consultation document cited a number of aspirations which included:-

- the need for HMIe to review the inspection framework regularly to ensure that it remained up to date
- deciding how to select schools for inspection in the future
- ensuring that inspection was seen as a positive, partnership experience
- ensuring that the principles set out in the government's response to the Crerar Review in 2007 were supported

Information was provided on proposals for the school inspection framework and the scope of the consultation which would run until 17 December 2010. Following an analysis of the responses, HMIe intended to introduce a pilot inspection framework during the summer term of 2011, with full implementation from September 2011.

To allow the Council's response to be submitted to HMIe by the closing date of 17 December 2010, it was proposed that the Executive Director (Education Resources), in consultation with the Chair and Depute Chair, be authorised to develop and submit the Council's response to HMIe.

#### The Committee decided:

- (1) that the Executive Director (Education Resources), in consultation with the Chair and Depute Chair, be authorised to develop and submit the Council's response to the HMIe consultation on proposals for the HMIe school inspection framework by the closing date of 17 December 2010; and
- (2) that a report on the consultation response be submitted to a future meeting of the Committee.

# 9 Implementation of the Education (Additional Support for Learning) (Scotland) Act 2009

A report dated 18 October 2010 by the Executive Director (Education Resources) was submitted on the commencement of the Education (Additional Support for Learning) (Scotland) Act 2009 (2009 Act) and the proposed arrangements for the implementation of the 2009 Act in South Lanarkshire.

The 2009 Act, which strengthened the Education (Additional Support for Learning) (Scotland) Act 2004 (2004 Act), would commence on 14 November 2010. Details were provided on the provisions of the 2009 Act and the main changes to the 2004 Act in Appendix 1 to the report.

The arrangements for the implementation of the 2009 Act included:-

- the revision of Operating Procedure A28 Additional Support for Learning information and guidance
- the revision, printing and distribution of information leaflets for parents and young people
- preparation and planning of a training programme to support staff in the implementation of the 2009 Act
- updating the Council's website
- liaison with Social Work Resources and the Scottish Children's Reporter Administration to ensure information regarding looked after children was accurate
- consideration of the implications of the 2009 Act in respect of placing requests
- the re-issue of the Future Planning Protocol to educational establishments and other appropriate agencies

#### The Committee decided:

that the arrangements, as detailed in the report, for the implementation of the Education (Additional Support for Learning) (Scotland) Act 2009 be approved.

## 10 School Holiday Dates for Session 2011/2012

A report dated 19 October 2010 by the Executive Director (Education Resources) was submitted on proposed holiday arrangements for schools in South Lanarkshire for session 2011/2012. Neighbouring education authorities, all teachers, trades unions and parent councils had been consulted on the proposals. The 5 dates on which teachers would attend in-service training had been excluded, with the exception of Monday 15 and Tuesday 16 August 2011. The remaining 3 dates would be determined locally in consultation with schools, learning communities and trades unions.

### 11 Community Learning and Development Strategy 2010 to 2014

A report dated 19 October 2010 by the Executive Director (Education Resources) was submitted on the Community Learning and Development Strategy 2010 to 2014.

The Strategy, which was attached as Appendix 1 to the report, addressed the following 3 national priorities:-

- achievement through learning for adults
- achievement through learning for young people
- achievement through building community capacity

Details were provided on the consultation process undertaken on the draft Strategy. Information was also provided on the key achievements during the 2007 to 2010 Strategy.

The Strategy would be delivered within existing resources of partner agencies and, where appropriate, external funding sources would be identified to enhance the provision.

## 12 Engaging Children and Young People in Cultural Activities

A report dated 21 October 2010 by the Executive Director (Education Resources) was submitted on the educational benefits of engaging children and young people in cultural activities. Scottish Screen and the Scottish Arts Council had invited local authorities to participate in the Creative Identities Programme. This was an 18 month pilot programme, funded through Cashback for Communities, which used arts and moving image media to provide creative learning activities for young people.

In South Lanarkshire, the project was primarily targeted at a range of looked after young people and young carers aged between 10 and 19 years and was delivered jointly by the Cultural Coordinator Team and South Lanarkshire's Young Carers Service.

Information on the numbers of young people who had participated in the programme, the range of activities that they had engaged in and evaluative comments made by those young people on the educational benefits gained through their participation in the programme was provided in Appendix 1 to the report.

The Chair, on behalf of the members of the Committee, praised the support provided by the Cultural Co-ordinator Team and South Lanarkshire's Young Carers Service to those participating in the programme.

The Committee decided:

that the educational benefits for children and young people gained through their involvement in cultural activities such as the Creative Identities Programme be noted.
