4 Application CR/06/0388 - Amendment to Planning Consent CR/05/0065 for Erection of 2 Storey Side Extension, etc in Respect of Various External Departures from Approved Drawings (Retrospective) at 22 Waverley Drive, Rutherglen

A report dated 17 September 2007 by the Executive Director (Enterprise Resources) was submitted on planning application CR/06/0388 by Mr and Mrs G Connor for an amendment to planning consent CR/05/0065 for the erection of a 2 storey side extension, etc in respect of various external departures from approved drawings (retrospective) at 22 Waverley Drive, Rutherglen.

The Planning officer advised that a request for a site visit had been received from an objector to the proposal but that the criteria for a site visit had not been met and there was no requirement to undertake a site visit prior to consideration of the application.

The Committee decided:

- (3) that, if necessary, an Enforcement Notice be served on the owner, occupier and/or lessee of 22 Waverley Drive, Rutherglen to ensure that works were undertaken to rectify the uneven, irregular and unsightly tiles attached to the side elevation of the 2 storey side extension at first floor level.
