Progress Update

1. Purpose of Report

3. Service Overview and Priorities

3.1. Electoral Registration

3.1.1 Rolling Registration

Invitation to register forms (ITRs) generated as a result of new Council Tax liabilities information received by LVJB continue to be issued, and registration applications received, including those via the government website (<u>www.gov.uk/register-to-vote</u>) continue to be processed.

3.1.2 Individual Electoral Registration

A bid for extra funding for the period 2016/17 has been approved by the Cabinet Office to cover additional expenditure as a result of the introduction of Individual Electoral Registration, in particular in relation to the costs incurred carrying out the annual canvass exercise. Indications from the Cabinet Office with regards to funding levels for 2017/18 are yet to be released.

3.1.3 Elections Held Since Last Board Meeting

The Local Government elections took place on 4 May 2017 with no issues raised in terms of electoral registration matters. The UK Parliamentary General election took place on 8 June with a number of issues arising. In particular, difficulty was experienced in meeting deadlines set by printing contractors in connection with the second run of poll cards and postal voting packs, principally due to a surge in registration applications in the run up to the deadline for registering (midnight 22 May 2017). A full review is underway to establish all the factors which contributed towards the delay and to ensure that there is no re-occurrence of this issue at future elections.

3.2.3 2010 Revaluation Appeals

A summary of the position with 2010 Revaluation appeals is contained within table 1 of appendix 1.4.

3.2.4 2010 Valuation Roll Outstanding Appeals (Running Roll)

A summary of the position with 2010 running roll appeals is contained within table 2 of appendix 1.4. Appeal decisions continue to be uploaded to the Lanarkshire Valuation Appeal Panel website – <u>www.lvap.org</u>

3.2.5 2017 Non Domestic Revaluation

Revaluation notices were issued on 15 March 2017 in time for the revised values coming into effect on 1 April 2017. Appeals are now being received and the impact on LVJB resources will be considered further once the deadline for receipt of such appeals (30 September 2017) has passed.

3.3 Council Tax

A summary of information in this area can be found in appendices 2.1 to 2.4.

3.3.1 New Houses

A summary of the position for the period 1 April 2016 to 1 June 2017 is contained at appendix 2.2.

3.3.2 **Proposals and Appeals**

Appendices 2.3 and 2.4 contain information on council tax proposals and appeals. Number of appeals outstanding at any one time have risen principally due to the introduction of increased payments to band E and above.

4. Staffing

- 4.1. Since the last Board meeting, one qualified Valuer has retired. LVJB's management team are currently considering the filling of the post, mindful of budgetary pressures.
- 4.2 Staff absence levels for the last year are summarised in appendix 3.0.

5. Other Matters

5.1 **Complaints Received and Dealt with Since Last Progress Update Report** Since the last update provided for the Board meeting, five complaints have been received and investigated, a summary of which is as follows:

Council Tax (ref: 2016/17 – 13) Council Tax	Complaint regarding the explanation in respect of a Council Tax banding of a property and over the authenticity of a previous withdrawal of an appeal. Complaint against conduct of	explanation given over the banding and copies of the previous appeal withdrawal provided by Assessor.
(ref: 2016/17– 14)	Assistant Assessor in respect of the time taken to get appeal cited for a hearing of the Lanarkshire Valuation Appeal Panel.	Assistant Assessor's conduct was entirely appropriate in the circumstances.
Electoral Registration (ref: 2017/18 – 1)	Complaint in relation to an elector no longer resident at an address.	Complaint resulted in an apology issued, and necessitated a reminder to staff of correct procedure in such circumstances. An amendment was also implemented to the relevant workflow.
Electoral Registration (ref: 2017/18 – 2)	Complaint re removal of an elector from the Register of Electors.	Letter of response issued advising that no response was received in connection with a review being undertaken in connection with a particular elector within a household, who shared the same name as his son. Elector re- instated to register and son removed.
Electoral Registration (ref: 2017/18 – 3)	Postal vote not received in time to vote at the Local Government elections in May 2017.	Application for Postal Vote was received by ERO on 12 April and acknowledged on 13 April. In accordance with an agreed procedure this information was passed to the RO on 19 April in time for the issue of Postal Votes by the RO on 25 April. Contact details for the Returning Officer included in letter of explanation.

5.2 **Complaints to the Ombudsman**

No decisions have been issued by the Scottish Public Services Ombudsman since the last progress update report to the Board.

5.3 Barclay Review of Business Rates

The Barclay review group, set up to make recommendations that seek to enhance and reform the business rates system in Scotland, is due to report to Scottish Government ministers in July 2017.
