1. Purpose of Report

1.1. The purpose of the report is to:-

- ◆ provide information on the progress of the capital programme for Finance and Information Technology Resources for the period 1 April 2009 to 4 September 2009.

- (1) that the Finance and Information Technology Resources capital programme of £1.559million, and expenditure to date of £0.324million be noted.

- 3.1. This is the first capital monitoring report presented to the Finance and Information Technology Resources Committee for the financial year 2009/2010.

5. Financial Implications

5.1. The total capital programme for Finance and Information Technology Resources for 2009/2010 is £1.559million. Anticipated spend to date was £0.300million with £0.324million of expenditure being incurred (20.8% of full budget). This represents a position of £0.024million ahead of profile. This time last year £0.377million was spent (19.0%).
