Councillor Shearer, seconded by Councillor Allison, moved as an amendment that the application be granted. On a vote being taken by a show of hands, 2 members voted for the motion and 8 for

the amendment which was declared carried. As this decision was contrary to Local Plan policy, the application would require to be referred to the Planning Committee for further consideration.

In addition, if consent was granted, the application would require to be referred to the Scottish Ministers as the proposal represented development in the greenbelt contrary to Development Plan policy.
