6 Civic Government (Scotland) Act 1982 (As Amended) – Application for the Renewal of Second-Hand Dealer's Licence No 34

A report dated 15 August 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the renewal of second-hand dealer's licence No 34 in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of her application. A representation had been received from Police Scotland, together with an additional update, and Inspector Hamilton was heard.

Comments had been received from Consumer and Trading Standards and D Grierson, Consumer and Trading Standards Officer was heard.

Councillor Callaghan, seconded by Councillor Donnelly, moved that the application be refused. Councillor Logan, seconded by Councillor Wardhaugh, moved as an amendment that the application be granted for a period of 1 year. On a vote being taken by a show of hands, 4 members voted for the amendment and 15 for the motion which was declared carried.

7 Civic Government (Scotland) Act 1982 (As Amended) – Application for Grant of a Private Hire Car Driver's Licence

A report dated 15 August 2019 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present or represented. A representation had been received from Police Scotland, together with an additional update.

The Legal Services' Adviser intimated that the applicant was unable to attend today's hearing, however, had requested that the application be dealt with in his absence.

Councillor Shearer, seconded by Councillor Carmichael, moved that the application be dealt with under written submissions. Councillor Hamilton, seconded by Councillor Donnelly, moved as an amendment that the application be continued to a future meeting of this Committee to allow the applicant the opportunity to be present. On a vote being taken by a show of hands, 10 members voted for the amendment and 8 for the motion. The amendment was declared carried.

The Committee decided:

that the application by R Hickinson, 22 Mansefield Crescent, Strathaven for a private hire car driver's licence in the East Kilbride zone be continued to a future meeting of this Committee to allow the applicant the opportunity to be present.

Subject: Civic Government (Scotland) Act 1982 (As Amended)

- Licensing of Taxis - Review of Taxi Fares

1. Purpose of Report

1.1. The purpose of the report is to:-

♦ to progress the fares review in the Clydesdale, East Kilbride, Hamilton and Cambuslang and Rutherglen zones of South Lanarkshire

2. Recommendation(s)

- 2.1. The Committee is asked to approve the following recommendation(s):
 - that, the review procedure for the East Kilbride, Hamilton and Cambuslang and Rutherglen zones be commenced on the basis that there should be no increase in the current fares tariff and the tariff should remain unchanged; and
 - that, the review procedure for the Clydesdale zone be progressed with an increase of 60 pence over a two mile hire.

3. Background

- 3.1. In terms of Section 17 of the Civic Government (Scotland) Act 1982 (as amended) by Section 174 of the Criminal Justice and Licensing (Scotland) Act 2010 Licensing Authorities must review taxi fares in their area every 18 months.
- 3.2. At its meeting held on 27 June 2013, the Licensing Committee agreed to calculate all future increases based on an agreed formula.

4. Present Position

- 4.1. East Kilbride taxi trade has indicated that this year they do not propose to seek an increase to the current fares tariff as per Appendix 1.
- 4.2. All Hamilton operators were written to although only a few operators have responded. One operator has requested an additional 10 pence be added to the running mile and the other eight operators who responded indicated that no fares increase is being requested. The fares tariff would therefore remain as per Appendix 1.
- 4.3. All Cambuslang and Rutherglen operators were written to although only one operator has responded who indicated that no fares increase is being requested. The fares tariff would therefore remain as per Appendix 1.

- 4.4. All Clydesdale operators were written to with a response being received from one operator who holds 29 of the current 85 taxi licences indicating that he would like an increase of 60 pence over a two mile hire. There has not been a fares increase in the Clydesdale zone since 2012. The current and proposed fares tariff are detailed in Appendix 2.
- 4.5. As members will be aware, even if there is no increase in the fares tariff, the formal review procedures require to be commenced.
