Subject: Civic Government (Scotland) Act 1982 Licensing of Second-Hand Dealers

1. Purpose of Report

- 1.1 The purpose of the report is to:-
 - finalise an amendment to the existing Resolution for the licensing of Second-Hand Dealers

2. Recommendation(s)

- 2.1 The Committee is asked to approve the following recommendation(s):-
 - (1) that the Final Resolution for the licensing of Second-Hand Dealers, as detailed in Appendix 1, be approved
 - (2) that authorisation be given to intimate the Final Resolution in appropriate newspapers for the Licensing of Second-Hand Dealers.

3. Background

3.1 In terms of the relevant legislation an advert, containing a Draft Resolution to amend the terms for which a Second-Hand Dealing Licence is required, was placed in newspapers circulating the area for the statutory period of 28 days. No adverse objections or representations have been received.

4. Final Resolution

- 4.1 To allow the list of activities to be amended, the next stage is for the Council to make a Final Resolution for Second-Hand Dealers.
- 4.2 A further advertisement will be required intimating that the Final Resolution has been made.

Appendix 1

Civic Government (Scotland) Act 1982 Licensing of Second-Hand Dealers

Final Resolution

South Lanarkshire Council, in terms of Section 9 of the Civic Government (Scotland) Act 1982, resolves that as from a date not less than 9 months from the date of the making of this Resolution, the following categories of Second-Hand Dealing within South Lanarkshire shall require to be licensed and regulated in accordance with the provisions of Section 24 to 27 (inclusive) of the said Act:-

- 1 Motor vehicles, motor vehicle spares and parts **including tyres**
- 2 Motor cycles and parts thereof **including tyres**
- 3 Caravans, motor homes and parts thereof
- 4 Bicycles
- 5 Domestic appliances
- 6 Furniture including mattresses, headboards, pillows and cushions
- 7 Jewellery, antiques, clocks, watches, gold, silver, medals, coins
- 8 Musical instruments
- 9 General household effects
- 10 Televisions and radios
- 11 Audio/video players and recorders
- 12 Toys
- 13 Trade person's tools and equipment
- 14 Photographic and cinematic equipment
- 15 Telephonic instruments including mobile phones, fax machines and associated equipment
- 16 **Computer hardware, games hardware and related software**
- 17 DVDs, CDs and other audio/video playback or recording mediums
- 18 Clothing

For the purposes of clarification, all previous Second-Hand Dealers resolutions will be revoked from the date this Resolution is passed.
