5 Multi Agency Public Protection Arrangements

A report dated 27 April 2007 by the Executive Director (Social Work Resources) was submitted on progress made in implementing the Multi Agency Public Protection Arrangements (MAPPA).

MAPPA was an administrative arrangement to improve effective co-ordination of information on individuals who were of high risk to the community. A MAPPA implementation group had been set up locally to provide a co-ordinated approach to operational practice. As part of the implementation of MAPPA, the Council's Housing Services and Health Services had been asked to identify a single point of contact.

It was proposed that a further report be submitted to a future meeting of the Committee on the work being undertaken to implement MAPPA.

6 Joint Future - Whole System Indicator (JPIAF10) 2006/2007

A report dated 19 April 2007 by the Executive Director (Social Work Resources) was submitted on the base data and self assessment template used by Social Work Resources to support Joint Performance Information and Assessment. The Framework enabled partnerships to self assess their performance in relation to other partnerships. The South Lanarkshire Partnership had performed well in 2006 moving to third place in Scotland.
