3. Area Plan

3.1. On the 13 September the Convenor received a letter from the Justice Secretary regarding the contents of our Area Plan 2011-14. The Justice Secretary formally approved the Plan and noted in particular the strong relationships created with partners.

Overall the panel considered this to be 'be a good comprehensive Plan with tangible time bound deliverables evidence linked to CJA strategic aims and with lead responsibilities identified.

4. National Outcomes & Standards Training Report

4.1. Between 14 September and 7 October 2010, 215 participants from North and South Lanarkshire Councils attended the revised National Outcomes & Standards training. The participants consisted of Service Managers, Senior Social Workers, Team Leaders, Qualified Social Workers from Justice and Child and Families teams, Community Service staff and Justice Social Work Assistants.

This training was co-ordinate and lead by the LCJA Training Officer Carol-Anne Soones and the evaluation of the training indicated the following very positive feedback.

- 77% of participants indicated that their immediate reaction to the course was that it was a good / extremely good investment of their time.
- 72% of participants indicated that they enjoyed the course.
- 77% found the training pack useful.
- 81% found that the course met their learning objectives.
- 71% thought the organisation, facilities and refreshments were good to excellent.

The National Outcomes & Standards exercise has been followed by similar exercises in relation to the new Community Payback order and the new Criminal Justice Social Work Report template.

5. Commencement of Community Payback Orders

5.1 The provisions of Community Payback Orders and the presumption against short prison sentences (less than three months) commenced on Tuesday 1 February 2011.

6. ADP Draft Terms of Reference

6.1 Following discussions between our partners in Health, Police, Prisons and Local Authorities a working group was established in September 2010 whose key purpose is to improve outcomes with substance misuse problems.

The draft remit for the group is attached for members' information and it is intended that the work of the group will contribute to a number of practical initiatives such as joint funded initiatives which will lead to an improvement in the health outcomes of offenders with substance misuse problems thereby reducing offending.
