4 Roads Investment Plan - Progress Report

A report dated 15 November 2010 by the Executive Director (Enterprise Resources) was submitted on progress with roads investment activity within the Cambuslang and Rutherglen area. Details were provided on the:-

- ◆ phasing of the additional £126 million expenditure on the Roads Investment Programme from 2008 to 2016
- ◆ level of expenditure allocated to each Council area including confirmation that £16.38 million would be spent in Cambuslang and Rutherglen over the 8 year programme
- ◆ increased expenditure on footways/footpaths
- ◆ priority scoring system for carriageway and footway/footpath schemes
- ◆ progress made in relation to the schemes within the Cambuslang and Rutherglen area which showed that 33 schemes had been completed or were programmed to be completed by the end of March 2011

The Committee decided: that progress with the Roads Investment Programme within the Cambuslang and Rutherglen area to date be noted.
