## 2 Minutes of Previous Meeting

## 3 HMle Report - St Patrick's Primary and Nursery Class, Strathaven

---

A report dated 14 February 2011 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of St Patrick's Primary School and Nursery Class, Strathaven made by Her Majesty's Inspectorate of Education (HMle).

The inspection had taken place in November 2010 as part of a national sample of primary and nursery education and the inspection report had been published on 18 January 2011.

Education Resources' employees would ensure that the recommendations contained within the report were followed up and that appropriate support was made available to the school. HMIe had intimated that they would make no further visits in connection with this inspection.

The Head of Education and the Headteacher spoke on key aspects of the report.

Members of the Committee congratulated the Headteacher on the outcome of the inspection and asked that their congratulations be relayed to the staff at the school and nursery class.

**The Committee decided:** that the report be noted.

#### **4 Corporate Parenting**

---

A report dated 26 January 2011 by the Executive Director (Social Work Resources) was submitted providing an update on progress with the implementation of a Corporate Parenting approach within South Lanarkshire. Details were provided on the following key areas:-

- ◆ the context and scope of the Corporate Parenting approach
- ◆ looked after children statistics for 2009/2010
- ◆ progress with the implementation of Corporate Parenting in South Lanarkshire
- ◆ the role of elected members in supporting the Corporate Parenting agenda, particularly in relation to agreeing and influencing priority needs and playing a specific role in scrutinising the approach

The Children and Family Services Manager spoke on key aspects of the report.

**The Committee decided:** that the report and considerable progress made in implementing the Corporate Parenting approach be noted.

#### **5 South Lanarkshire Leisure and Culture Update**

---

The General Manager gave a presentation advising:-

- ◆ of the formation of South Lanarkshire Leisure and Culture (SLLC) on 1 October 2010, which had resulted from the expansion of South Lanarkshire Leisure to include South Lanarkshire Council's community and town halls, museums, country parks, arts development and library services
- ◆ that SLLC was the second largest integrated sports and cultural organisation in Scotland
- ◆ that the initial challenge of integration with minimal service disruption had been achieved as a result of partnership working between South Lanarkshire Leisure and South Lanarkshire Council
- ◆ that employees' terms and conditions were consistent with those of South Lanarkshire Council
- ◆ that a £1 million tax saving could be achieved if SLLC maintained its charitable status
- ◆ that there had been significant funding made available from South Lanarkshire Council's Capital Programme to upgrade community halls, libraries and sports facilities
- ◆ of the possible integration of a library facility at the Stonehouse integrated community facility

In response to members' questions, the General Manager advised that work was being carried out to re-open the Dollan Aqua Centre by the end of May 2011. 1,500 young people had attended swimming lessons at the Dollan Aqua Centre prior to its refurbishment and they had all been contacted regarding arrangements following the re-opening.

**The Committee decided:** that the contents of the presentation be noted.

**8 Twinning Grant Application - Claremont Amateur Football Club**

---

A report dated 11 February 2011 by the Executive Director (Corporate Resources) was submitted on an application by Claremont Amateur Football Club for a twinning grant which had been assessed as meeting the relevant criteria. The purpose of the grant was for a sporting/social exchange involving 18 participants travelling to Ballerup, Denmark from 1 to 10 July 2011.

**The Committee decided:**

- (1) that a twinning grant of £540 be awarded to Claremont Amateur Football Club for a sporting/social exchange to Ballerup, Denmark from 1 to 10 July 2011; and
- (2) that the Executive Director (Corporate Resources), in consultation with the Chair or Depute Chair, be authorised to vary the award, if necessary, to take account of the final number of participants involved in the twinning link.
