1. Purpose of Report

1.1. The purpose of the report is to:-

In these instances a report is submitted to the appropriate Committee and subsequent authority to award is granted by that Committee.

5.1. Contracts management including performance appraisal will be undertaken by both the main user Services and Procurement.
