### **Provost's Opening Remarks**

### **1 Declaration of Interests**

No interests were declared.

### **2 Designation of Burial Ground - Lanark and Carnwath**

A report dated 24 August 2011 by the Executive Director (Community Resources) was submitted advising that, in terms of Section 9 of the Burial Grounds (Scotland) Act 1855, the Chief Executive had received a requisition signed by Councillors Gauld and McNeill to convene a special meeting of the Council for the purpose of determining whether one or more burial grounds should be provided within the areas of Lanark and Carnwath in the area of South Lanarkshire.

In terms of the 1855 Act, the Council had a statutory responsibility to ensure that there was suitable cemetery capacity in its area. Particular capacity issues had been identified at both Lanark and Carnwath Cemeteries where it was estimated that all available lairs would be used within 1½ years and 1 year respectively.

An assessment of potential sites had been made and the following 2 sites had been identified as suitable to enable the Council to meet its statutory responsibility:-

- ◆ an area of ground at Springbank Farm, Lanark as detailed on the plan attached as Appendix 1 to the report
- ◆ an area of ground adjacent to the existing Carnwath Cemetery as detailed on the plan attached as Appendix 2 to the report

It was, therefore, proposed that the areas be designated as burial ground and that the Executive Director (Enterprise Resources), in consultation with the Head of Legal Services, if appropriate, be authorised to conclude all matters on terms which were in the best interests of the Council.

Capacity issues had also been identified at Strathaven and Larkhall Cemeteries and work was ongoing to allow the Council to meet its statutory responsibility at those locations. Further reports in relation to those 2 areas would be submitted at the appropriate time.

**The Council decided:**

- (1) that the areas of ground at Springbank Farm, Lanark and adjacent to the existing Carnwath Cemetery, as detailed on the plans attached as appendices to the report, be designated as burial ground; and
- (2) that the Executive Director (Enterprise Resources), in consultation with the Head of Legal Services, if appropriate, be authorised to conclude all matters on terms which were in the best interests of the Council.
