Public Entertainment Licence - Renewal (Cinema Act)

Late Hours Catering - Renewal, Odeon Cinema, Olympia Centre, East Kilbride

I refer to the above, your recent request for comment received 21 September 2011 and my surveyors' previous comments of 27 June 2011 following an inspection of the same date.

I write to report the following issues were observed by my surveyor during his inspection that require to be attended to:

- Repair escape route lighting within escape stair adjacent to screen 4,
- Ponded water was observed at the bottom of the escape stair adjacent to screen 4, this does not appear to be as a result of rainfall as no ponded water was observed to the outside of the door, and the exit door is located in a sheltered location. Some investigation will be required to identify the source of this water as it would form an obvious hazard to patrons making their escape from the premises in the event of an emergency situation,
- Contrasting nosing to be provided to the stairs in the escape stair adjacent to screen 6,
- Removal of all stored items and refuse items from the escape stair adjacent to screen 6.
- Fire exit keep clear signage to the reverse of the exit doors from the upper floor/staffroom/projection room areas.
