## 1. Purpose of Report

1.1. The purpose of the report is to:-

- ◆ request formal approval of grants to local voluntary organisations which meet the criteria for receiving financial support

## 2. Recommendation(s)

2.1. The Committee is asked to approve the following recommendation(s):-

- (1) that the proposed allocation of funding to the following voluntary groups be approved as follows:-

◆ Age Concern East Kilbride	£5,488
◆ Avondale Community Transport	£490
◆ East Kilbride Community Transport	£5,390
◆ Greenhills Out of School Care	£4,410
◆ Greenhills Youth Club	£735

## 3. Background

3.1. On 8 July 2009, the Executive Committee approved a report extending the responsibility of Area Committees to include the formal approval of grants to local voluntary organisations. At its meeting on 23 February 2011, the Executive Committee approved the overall grants funding package for 2011/2012, and it is now for the Area Committee to approve local grants to those organisations operating in their local area.

## 4. Current Position

4.1. The Council has received applications from voluntary organisations operating in the East Kilbride Area Committee area, which meet the criteria for receiving financial assistance. In line with the report submitted to the Executive Committee, it is proposed that grant funding be allocated to these organisations based on levels of funding which the groups have received in previous years.

## 5. Employee Implications

5.1. There are no employee implications associated with the recommendations made in this report.

## **6. Financial Implications**

- 6.1. The financial implications associated with the recommendation(s) contained in this report can be met from the Corporate Resources' Revenue Budget 2011/2012.
