3.1. Following agreement at the Board Meeting of the 4th of June the final draft of the Area Plan was submitted to the Scottish Government on the 4th of June. The Chief Officer was invited to attend the Scrutiny Panel on the 13th of July and will receive feedback in due course.

4. Quarterly Performance Report

4.1. The Quarterly Performance Report is attached for information. I would particularly like to highlight that the national target of 85% attendance at Integrated Case Management case conferences continues to be exceeded within Lanarkshire. In addition activities to promote work within the LCJA area has had a particularly successful quarter with the following events:

- Community Service Awards in Glasgow - NLC were successful in the following categories: Women's Aid, Cumbernauld came first in the 'Partnership' category. Shott's Memorial Garden received a Highly Commended in the 'Communities' category and a Commended in the 'Skills Building' category for their Market Garden.
- In addition a timetable was agreed for MSP Kenny MacAskill to visit Langlands Moss in East Kilbride, the Sentinel Project in Cambuslang and officially open Auchentibber in Blantyre.
