9 Civic Government (Scotland) Act 1982 (As Amended) - Application for Short Term Let Licence

A report dated 25 April 2024 by the Executive Director (Finance and Corporate Resources) was submitted on an application for a short term let licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

A petition dated 31 October 2024 had been received from local residents objecting to the application. Additional correspondence had been received from some of the petitioners advising that, with certain conditions agreed with the applicant, they were happy to withdraw their objections. The Legal Services' Adviser also intimated that one petitioner had advised that he wished his objection to remain, and the remaining petitioners had not responded.

Following discussion, members agreed that there was no need to attach any additional conditions to the licence.
