3 Scottish Fire and Rescue Service

S Kennedy, Station Manager, Clydesdale Community Fire Station, Scottish Fire and Rescue Service gave a presentation providing information on progress made during 2015/2016 against the key priorities within the Local Fire and Rescue Area Plan. The current Local Fire and Rescue Area plan for South Lanarkshire contained the following key priorities:-

- ◆ local risk management and preparedness
- ◆ reduction of dwelling fires
- ◆ reduction of fire casualties and fatalities
- ◆ reduction of deliberate fire setting
- ◆ reduction of fires in non-domestic properties
- ◆ reduction in road traffic collisions
- ◆ reduction of unwanted fire signals

The performance report provided detailed analysis of relevant performance information covering the period April 2015 to March 2016. In order to provide a comparison, performance information was also provided for the financial years 2011/2012 to 2014/2015.
