3. Background

3.1. The Council operates a community grants scheme to support local constituted community groups and voluntary organisations. Applications are invited continually through the year.

All applications require to be supported by a constitution, audited accounts and a bank statement.

At its meeting held on 9 March 2011, the Committee authorised the Executive Director (Corporate Resources), in consultation with the Chair, to approve any further community grant applications in the period from 9 March 2011 to 31 March 2011 subject to the applications meeting the Council's criteria for receipt of funding. 6.2. On the basis that the playscheme grants detailed in a separate report on this agenda amounting to £4,000 are approved, the remaining balance for allocation throughout the year is £35,570.

7. Other Implications

7.1. The risk to the Council is that grant funding is not utilised for the purpose of which it was intended. This risk is mitigated by internal controls including audit procedures and a conditions of grant agreement.

7.2. There are no apparent implications in terms of sustainable development.
