### **3 HMle Report - Hunter Primary School, East Kilbride**

A report dated 2 December 2010 by the Executive Director (Education Resources) was submitted on the outcome of the inspection of Hunter Primary School, East Kilbride made by Her Majesty's Inspectorate of Education (HMle).

The inspection had taken place in May 2010 as part of a national sample of primary education and the inspection report had been published on 24 August 2010. Education Resources' employees would ensure that the recommendations contained within the report were followed up and that appropriate support was made available to the school. HMIe had indicated that they would make no further visits in connection with this inspection.

The Head of Education and Headteacher spoke on key aspects of the report and responded to members' questions.

#### **4 Roads Investment Programme - Progress Report**

---

A report dated 23 November 2010 by the Executive Director (Enterprise Resources) was submitted on the progress of the Roads Investment Programme in the East Kilbride area. Details were provided on the:-

- ◆ phasing of the additional £126 million expenditure on the Roads Investment Programme from 2008 to 2016
- ◆ level of expenditure allocated to each Council area including confirmation that £32.76 million would be spent in the East Kilbride Area Committee Area over the 8 year programme
- ◆ increased expenditure on footways/footpaths
- ◆ priority scoring system for carriageway and footway/footpath schemes
- ◆ progress made in relation to the schemes within the East Kilbride area which showed that 69 schemes had been completed or were programmed to be completed by the end of March 2011
