A report dated 26 August 2021 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was present and heard in support of his application. A late objection had been received from Police Scotland. The reason for the lateness of the objection was accepted and Sergeant Rankin was heard on behalf of Police Scotland.

Councillor McLachlan, seconded by Councillor Corbett, moved that the application be refused. Councillor McGuigan, seconded by Councillor Donnelly, moved as an amendment that the application be granted for a period of 1 year.
