## 1 Declaration of Interests

## 3 Exclusion of Press and Public

## 4 Civic Government (Scotland) Act 1982 (As Amended) - Application for Private Hire Car Driver's Licence - Consideration of Late Report from Police Scotland

A report dated 14 February 2022 by the Executive Director (Finance and Corporate Resources) was submitted on the reason for the lateness of an objection from Police Scotland to an application for a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

Where an application was received under the Civic Government (Scotland) Act 1982, there was a statutory objection period of 28 days from the date of application.

A letter of objection had been received from Police Scotland outwith the 28 day objection period. The reason for the lateness of the objection was given by Police Scotland.

**The Committee decided:** that the reason for the lateness of the objection from Police Scotland be accepted to allow full consideration of the application.

## **5 Civic Government (Scotland) Act 1982 (As Amended) - Application to Vary the Terms of Market Operator Licence No 004**

---

A report dated 17 February 2022 by the Executive Director (Finance and Corporate Resources) was submitted on an application to vary the terms of market operator licence No 004 in terms of the Civic Government (Scotland) Act 1982 (as amended).

**The Committee decided:** that the following application to vary the terms of market operator licence No 004 be granted subject to the conditions specified by the Executive Director (Finance and Corporate Resources):-

## **6 Civic Government (Scotland) Act 1982 (As Amended) - Consideration of Suspension or Revocation of Taxi Driver's Licence No 194**

---

A report dated 17 February 2022 by the Executive Director (Finance and Corporate Resources) was submitted proposing that consideration be given to whether taxi driver's licence No 194 should be suspended or revoked.

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the licence holder who was present and heard in support of retaining his licence. A letter of complaint had been received from Police Scotland and Sergeant Gill was heard.

Following discussion, Councillor Shearer, seconded by Councillor Donnelly, moved that the licence be suspended with immediate effect for a period of 2 weeks. Councillor Carmichael, seconded by Councillor McCreary, moved as an amendment that the licence be suspended with immediate effect for the remainder of the period of licence.

## **7 Civic Government (Scotland) Act 1982 (As Amended) - Application for Grant of Private Hire Car Driver's Licence**

---

A report dated 17 February 2022 by the Executive Director (Finance and Corporate Resources) was submitted on an application for the grant of a private hire car driver's licence in terms of the Civic Government (Scotland) Act 1982 (as amended).

In terms of the Civic Government (Scotland) Act 1982 (as amended), the opportunity of a hearing had been offered to the applicant who was not present or represented. An objection had been received from Police Scotland.

The Committee noted that the applicant had been given notice of the hearing and, having been advised of the efforts made to contact the applicant, the Committee was satisfied that it was appropriate to proceed to consider the application in the applicant's absence.

**The Committee decided:** that the application by H Karimi, Flat 9E, 10 Broomhill Lane, Glasgow for the grant of a private hire car driver's licence in the Cambuslang and Rutherglen zone be refused.
